Purpose of the Report

Background

- 2 At the Committee's meeting held on 4 November 2015, members received a presentation detailing the results of the Care Quality Commissions inspection of County Durham and Darlington NHS Foundation Trust.
- 3 The CQC published its inspection report for County Durham and Darlington NHS Foundation Trust on 29 September 2015 and assessed the Trust as "Requires Improvement".
- 4 Sue Jacques, Chief Executive of County Durham and Darlington NHS Foundation Trust attended the meeting to present the key findings from the inspection and also to highlight those measures and actions that the Trust were implementing in respect of these findings.
