1 ELECTION OF CHAIR

RESOLVED that Mr W Local be elected Chair of the Standards Committee for the ensuing year.

2 **APPOINTMENT OF VICE CHAIR**

RESOLVED that Councillor B Burn be appointed Vice Chair of the Standards Committee for the ensuing year.

3 **THE MINUTES OF THE LAST MEETING** held on 23 April 2007, a copy of which had been circulated to each Member, were confirmed.

4 REQUEST FOR DISPENSATION FROM SOUTH HETTON PARISH COUNCIL

The Monitoring Officer provided details of a request for dispensation from the obligation to declare a prejudicial interest at South Hetton Parish Council when considering business which affected South Hetton Cricket Club.

Members were advised that South Hetton Parish Council regularly considered items of business affecting the Cricket Club and seven of the nine Members of the Parish Council were involved with this organisation.

The quorum to conduct business was three and the declaration of interest would lead to the Council being unable to progress its business due to the lack of a quorum.

It was not considered likely that any of the seven Councillors involved would receive any personal gain from decisions which affected the Cricket Club.

The Relevant Authorities Standards Committee (Dispensations) Regulations 2002 permitted the Standards Committee to grant dispensation in those circumstances if they considered that the transaction of the Council's business would be impeded as a result of the Code of Conduct and if taking all these circumstances of the case into consideration they considered it appropriate to grant dispensation.

RESOLVED that: -

- (i) approval be granted for the dispensation for the seven named Members of South Hetton Parish Council to participate and debate in decisions concerning South Hetton Cricket Club;
- (ii) the dispensation to run for the life of the current Council.

5 ANNUAL ASSEMBLY OF THE STANDARDS BOARD FOR ENGLAND

Members were advised that at the last meeting it was agreed that the Monitoring Officer together with one Member of the Standards Committee be authorised to attend the Annual Assembly of the Standards Board for England to be held on 15 and 16 October 2007.

The Chair requested nominations for attendance. Councillors B Burn and Miss J Clark advised that they were unable to attend. E Smith advised that he may be able to attend and would confirm by the end of June 2007.

Following discussion it was **RESOLVED** that consideration of this item be deferred.
