1 **THE MINUTES OF THE MEETING OF THE DISTRICT COUNCIL OF EASINGTON** held on 6 October, 2005, a copy of which had been circulated to each Member, were confirmed.

2 USE OF GENERAL FUND RESERVES

Consideration was given to the report of the Director of Finance and Corporate Services which gave details of proposals for the use of General Fund Reserves, a copy of which had been circulated to each Member.

The Director of Finance and Corporate Services reported that on 5 July, 2005 the Executive agreed in principal to release ± 1.5 million of the General Fund Reserves subject to a further report. Since that time Directorates and Portfolio Holders had considered a number of projects for submission based on certain criteria, details of which were set out in the report.

Business cases were prepared for each submission and proposed service investments for consideration were set out in Appendix 1 to the report.

The commitment of an additional ± 1.5 million into the budget was significant and therefore, the Council had to ensure that the investments achieved value for money and delivered the outcomes identified. Members were therefore asked to consider a review process to track progress and achievement of the projects.

The Leader of the Council stated that the proposed projects had been identified as current priorities of the Council which could be subject to change. Therefore, whilst approval was being sought to the list of projects outlined in the report, any additional submissions could be considered, in line with the established criteria and the preparation of a business case. In terms of the review process, it was proposed that regular reports would be submitted to Scrutiny Management Board to track progress and achievement of the projects.

RESOLVED that:-

- (a) £1.5 million be released from the General Fund Reserves;
- (b) the proposals for the use of reserves as outlined in Appendix 1 to the report, be approved;
- (c) regular reports be submitted to Scrutiny Management Board on progress of the projects identified.
