1. Purpose of Report

1.1 The purpose of this report is to advice the Executive of the outcome of consultation on the Draft Statement of Community Involvement (SCI) prior to submission to the Government Office for subsequent independent examination.

2. Consultation

2.1 Appendix 1 is a list of the organisations/individuals who have been consulted on the Draft SCI. The Chief Executive and Management Team have been consulted and support the proposals recommended in this report.

3. Background

- 3.1 The Planning and Compulsory Purchase Act 2004 introduces a new planning system which is intended to promote a more proactive, positive approach to managing development. Development plan documents will continue to be the essential framework for planning decisions but, through a process of 'front loading', community and stakeholder involvement must be sought from the outset. This is to achieve local ownership and legitimacy for the policies that will shape the future of the area.
- 3.2 The Council's proposals to facilitate engagement in the planning process need to be identified in a Statement of Community Involvement (SCI). The document will form part of the Local Development Framework and should set out the Council's policy and standards for involving the community and stakeholders in the preparation of both development plan documents and planning applications, to meet the requirements of the Act.
- 3.3 In the Local Development Scheme approved by the Council in March 2005, it was proposed that the SCI would be submitted to the government office by the end of October 2005. It will then be subject to independent examination early next year, before it can be formally adopted. The Inspectors report will be binding on the Council.

4. Position Statement and Option Appraisal

- 4.1 The draft SCI proposed for submission has been previously circulated and is available in the Members Library. It seeks to promote effective community involvement in all aspects of planning, including development plan preparation and planning applications. Whilst consultation on planning matters is largely a statutory requirement laid down by Regulations, the SCI also needs to consider the Council's corporate approach to engagement, using existing mechanisms where possible, to involve all sectors of the community, through a range of communication methods, and to explore opportunities to link to engagement with the Community Strategy. The draft document also reflects the consultation procedures laid down in the Council's Development Control Manual which is accepted good practice.
- 4.2 To meet statutory Regulations, formal consultation was undertaken on a draft document, for a statutory 6-week period, from 22nd July to 2nd September 2005. Representations are currently being considered and minor amendments will be made to the draft SCI in response to these before the final document is presented to full Council in October for approval to submit to GO-NE.
- 4.3 Thirteen responses were received in total and appendix 2 gives full details of these responses. Responses at the time of this report generally support the core principals of the document but amendments by and large relate to the detail of information in some sections and the layout of the document to improve clarity.

5. Implications

5.1 Financial

There are no financial implications, funding requirements will be met from existing budgets.

5.2 Legal

There are no legal implications.

5.3 Policy

The SCI sets out the Council's policy for consultation on planning matters. An amended document will be reported to full Council for final approval.

5.4 Risk

As this is a technical document, there is no risk.

5.5 Communications

The amended SCI will be submitted to the Government Office in October and advertised for formal public consultation in accordance with the Regulations. Following an independent inquiry anticipated in spring 2006, the Inspector's binding report will be reported back to the Council for final adoption into the LDF.

Additional diagrams would also help this chapter, for example a diagram showing the content of the LDF and another illustrating the SCI process with dates. Paragraph 1.2 could incorporate the text in paragraph 2.9 - Effective Community Involvement, as it relates to more than this paragraph. Please expand the bullet points currently in paragraph 2.9 to include all the points in Planning Policy Statement 1 - paragraph 4.3. Paragraph 2.2 also contains similar information. Paragraph 1.4 should give more details of the LDF process and the saving of existing policies for three years i.e. a gradual replacement of thee existing Local Plan. Paragraph 1.5 could be relocated to paragraph 1.5, possibly augmented with a diagram (see above). I would also suggest you give more prominence to the Core Strategy rather than list the documents in chronological order of preparation. a) The diagram should be titled 'stages in development plan document preparation' in order to distinguish this from the SCI process. To aid understanding is it possible to relate the text beneath more closely to the diagram?

Chapter 2 - Corporate Approach to Community Engagement and Involvement - Paragraphs 2.6 and 2.7 could be condensed and more targeted as to the role of the LSP within the community involvement process, possibly incorporating the text in paragraph 3.11.

Chapter 3 - Community Involvement in Development Plans - In paragraph 3.8 could you amend the list of hard to reach groups to include 'gypsies and travellers' rather than just 'travellers' ?

Para 3.10 to 3.27 (Consultation methods) - could be incorporated into a matrix which could show which the participation techniques to be used for the different types of documents and stages of the production process (ref 'Creating Local Development Frameworks' page 75 step 5). This would enable the SCI to better satisfy the Tests of Soundness, particularly Test V, as detailed in Planning Policy Statement 12 paragraph 3.10. Some of this section is more of a description of groups rather than consultation methods.

Para 3.29 should also mention the Annual Monitoring Report's role to provide feedback and monitor the consultation process and success of the SCI

Chapter 4 - Community Involvement on Development Control Matters - There is a lot of detail in the chapter but I felt the focus was not always on community involvement but rather on the development control process itself e.g. paragraph 4.10. All the means by which people can contact the council would be better located together rather than spread throughout this chapter and elsewhere, e.g. paragraphs 4.2, 4.3, 4.8 and 3.24.

Chapter 5 Recommended Community Involvement to be undertaken by Developers and Agents - it would be helpful to provide more detail about what is meant by 'significant others' in the list provided in paragraph 5.3. The Best Value definitions for significant applications could be applied here with any adaptations for local conditions.

Highways Agency

Not wishing to make any specific comment at this stage

East Durham Business Service

Welcome measures set out in 4.7 & 4.16 - require monitoring/feedback to ensure they are implemented.

Chapter 5 is useful to the private sector.

But suggest amendment to p. 27'general consultation bodies' - last point - to read as:- 'Bodies which represent the interests of business in the authority's area, such as the East Durham Business Forum'

Where does the County Council fit? - it is not the regional planning body & it is not the local planning authority for an area adjacent.

Durham County Council

Appendix 1 refers to the HBMCE as a specific consultation body. However, the organisation is better known by the public as English Heritage. I would ask that Appendix 1 be amended accordingly.

English Heritage

Chapter 4 advises that the time permitted for a response from statutory consultees is set at 21 days from the date of notification. From the English Heritage Charter, however, you will see that it is 21 days from the date of receipt. This service level had been agreed with the DCMS, and is predicated on paragraphs 108 and 109 of the Draft Town and Country Planning (General Development Procedure) (Amendment) (England) Order 2004. It states 'The statutory deadline will have been met if the statutory consultee submits its response with 21 days starting on the day on which [it] receives notice of an application'. This is a matter which it might be useful for us to discuss.

Paragraph 4.4 should clarify what is meant by a 'major' application.

Paragraph 4.12 gives guidance on when applications will be put to the Council's DCRP. Clarification is needed with regard to what constitutes a 'large' number and what is meant by 'significant'.

The Countryside Agency

The Woodland Trust

Horden Parish Council

Unable to offer comments on this occasion - absence of comment is simply an expression of out priorities.

The Woodland Trust would like to be added to the environmental organisations in Appendix 1 'Other Consultees' to be consulted on planning policies in the development of the LDF. Currently we believe that the SCI fails the soundness test of the identifying in general terms which local community groups and other bodies will be consulted. We would also like to be added to the list of consultees for planning applications that directly or indirectly affect ancient woodland.

When planning permission has been granted certain conditions are identified. We have found it is difficult to pin down who is responsible for checking & monitoring that these conditions are met. Especially on a self build site. Could this be itemised in

Seaton Parish Council Development Control matters.

Parish Councils should be consulted with sufficient timescale for response rather than 'kept fully informed of progress'. Parish Councillors are elected representatives of the communities.

Parish Councils should be included in list of statutory consultees in the specific Consultation Bodies section.

I note that the Forestry Commission is on the list of other consultees in appendix 1 of the SCI and that as such you will consult us, where appropriate, in the preparation of local development documents. We welcome this and look forward to further consultations, as the LDF is prepared. We would also like to be consulted on some individual planning applications. The type we have an interest in and further details on this are given below. Also, we suggest that 'planning applications having an adverse effect on ancient woodland or veteran aged trees' is listed under other types of planning applications on page 21. This is in line with PPS 9 that has just been issued (further details below). Subject to this we support the SCI as drafted.

Forestry Commission

We would welcome the opportunity to be consulted on any planning applications where the proposed development may have adverse effect on ancient woodland.

Furthermore we would encourage you to consult us whenever you are considering a planning application for a development that will have an adverse effect on any other type of woodland too.

Similarly we encourage you to advise us of any instances you are aware of where we may need to be involved because of our responsibilities under the forestry EIA regulations (described above) or where there might have been a breach of the felling license regulations.

We would welcome the opportunity to be involved and to provide technical advice when you are considering forest industry or forestry related developments.
