COUNCIL PROCEDURE RULE NO. 9.2 QUESTIONS BY MEMBERS

1. The following question was received, by the due date, from Councillor Taylor and was addressed to the Portfolio Holder for Strategic Planning and Regeneration.

"Would the Portfolio Holder inform me of who was responsible for the drafting of the press release to the Northern Echo newspaper which was published on Monday October 22nd, referring to the Brandon Masterplan?

Could he give me his opinion as to how elderly people living in the properties mentioned might have felt after reading that they could be moved out of their home or that their home could be demolished or knocked down?

Does the Portfolio Holder agree with me that it was totally insensitive to mention specific areas of Brandon without first presenting the Masterplan to the people of Brandon by means of a public meeting and will he give me an undertaking to organise a public meeting in Brandon?"

2. The following question was received, by the due date, from Councillor Taylor and was addressed to the Leader of the Council.

"At the last meeting of this Council Councillor Reynolds alleged that I had been unsupportive of the Brandon Masterplan.

I asked the Leader of the Council to substantiate that allegation he declined to do so.

Will he now do so or is he prepared to withdraw his allegation?"

3. The following question was received, by the due date, from Councillor Taylor and was addressed to the Portfolio Holder for Strategic Planning and Regeneration.

"I am sure that the Portfolio Holder agrees with me that Durham is in need of Affordable Housing.

If he does, could he explain to me why the proposed development on the Greenfield Site at the bottom of Commercial Street in Brandon is not for affordable housing?"
