Report of the Director of Financial Services

543. STATUTORY DETERMINATIONS - COUNCIL TAX SETTING

Council at its meeting of 26th February 2008, were unable to consider items 2.4 and 2.5 of the Report of the Director of Financial Services and as a result were unable to set the Council Tax for 2008/09. This was due to the fact that the Police Authority had not, at that point, reached agreement over their precept for 2008/09.

At its meeting of 27th February 2008, the Police Authority were able to approve their budget and reached agreement on a precept of £3,757,588 on the City Council's Collection Fund, giving a Band D Council Tax of £142.47 in 2008/09, an increase of 4.97%.
