Leisure Centres - Section (D)

"Members may recall that I questioned this disparity between Abbey Leisure Centre and the other Leisure Centres last year when scrutinising the Budget.

Abbey **Annual Membership** £250.00 (2007/2008), increased by 5% (2008/2009) due to inflation (increase of £12.50 to £262.50) and casual usage has increased by 5%.

I accept the Directors' (Director of Finance) explanation last year that the facilities at Abbey Leisure Centre were greater than at the other Leisure Centres, **and that we are moving towards removing the differential.**

Firstly the quality of equipment, although better than the rest (of the other Leisure Centres), is far from ideal and has not been improved since last year. I have received complaints about the state of the squash courts. Secondly, it also needs to be borne in mind that the facility was built with funding from Community Gain, £1,000,000+.

Accordingly, I find it difficult to expect local Residents to pay more for a better facility that was given to given to their community at no/little cost to the Authority.

If we do not reach parity (Abbey Leisure Centre fees being equal to the other Leisure Centre) this year (2008/2009), when can we expect it?"
