Report of Monitoring Officer

74. COMPLAINTS TO THE STANDARDS BOARD FOR ENGLAND

(a) SBE 21948.08 – SBE 21953.08

The Standards Board for England had confirmed that they had received a complaint in respect of the conduct of five parish councillors. The basis of the complaint was that the Members had participated in a decision by the Parish Council to donate money to a community association when they sat on the management committee of the association.

The Standards Board for England had advised that the matter had been referred to an Ethical Standards Officer, and the Committee would be updated on the progress of the matter in due course.

Resolved: That the report be noted.

(b) SBE 21976.08

The Standards Board for England had received a complaint concerning the alleged conduct of a Member of West Rainton and Leamside Parish Council. The Standards Board for England assessed the allegation and decided not to refer the complaint for investigation as it believed Standards Committee had already taken a view on the veracity of the evidence given by the Councillors and it was therefore not appropriate for the Standards Board to reconsider an aspect of a matter that had already been concluded.

Resolved: That the report be noted.

75. COMPLAINTS TO THE STANDARDS COMMITTEE

A complaint had been received in respect of the conduct of a parish councillor. The basis of the complaint was that the Member had ignored correspondence, admitted acting to confer a detriment on the complainant and, as a consequence, brought the Authority into disrepute.

In accordance with the Local Assessment Procedure, a meeting of the Standards Committee Local Assessment Sub-Committee had now been convened, and Members would be updated on the progress of the matter in due course.

Resolved: That the report be noted.

76. COMPLAINT FORM

A copy of the complaints form had been considered at the last Meeting of the Committee, and following comments made, an updated form had now been produced to reflect these. A copy of the amended form had been circulated.

A copy of the guidance which it was proposed be adopted was also circulated for Members' information.
