INTRODUCTION

Wear Valley District Council has long valued the views of its customers and has continually developed ways in which customers can be involved in the decision making process.

In addition to the Wear Valley Customers Compact which was developed in 2003 and which has received recognition by the ODPM as an example of Good Practice, the Community Involvement Team and Housing Staff work regularly with both the resident's associations, the Wear Valley Customer Panel and individual customers to develop and improve the services they offer, most recently consulting widely on the Stock Options Appraisal and the development of new Service Standards.

This Strategy has been designed to be flexible and to provide appropriate levels of engagement that suits our wide range of customers. This Strategy also includes an Action Plan to achieve our aims and objectives.

This Strategy has been developed alongside the principles of Best Value, which aim to provide cost efficient and high quality services, responsive to local peoples needs and aspirations.

For this reason the Council: -

- Ensures that customers have a real say in decisions that have an effect on the community, housing and area in which they live.
- Has implemented a framework that allows customers to be involved in decisions that affect their housing and local area at a level they are comfortable with.
- Delivers quality services that reflect the needs and priorities of local people.
- Upholds the principles of the Wear Valley Customers Compact that demonstrates a commitment to working in partnership towards improving housing services, people's homes and their neighbourhoods.

WEAR VALLEY IN CONTEXT

Wear Valley is one of the seven local authorities that form County Durham. The District spans 30 miles from east to west, with almost half lying in the North Pennines Area of Outstanding Natural Beauty.

Wear Valley is a mixture of both urban and rural areas with the majority of the population living in the more urban parts of the district, these areas include the towns of Bishop Auckland and Crook.

The Housing Services Department currently owns and manages 5172 homes and provides a wide range of housing and other general services to their customers. The key strategic objectives of the Housing Services Department are:

- Delivering ever improving Community Safety and reducing fear of crime
- Delivering ever improving greener, cleaner and healthier environment

People and Community:
