CAPITAL WORKS PERFORMANCE 2007/08 AND PROPOSED 2008/09

PROGRAMME

purpose of the report

To update Committee on the delivery of the capital programme 2007/08 in relation to its housing stock and private sector improvements, and to seek approval for the proposed 2008/09 programme.

background

- Members will be aware that the capital budget was set in February 2007 and subsequently revised at a Special Council meeting on 4 September 2007 in order to commit the Council to use all of its resources.
- 2 As part of the Council's 2007/08 budgetary process the Council committed resources towards:-
 - improving the standard of life to some of our most vulnerable and needy customers by enabling specialist adaptations to be made to both private and public sector houses. These adaptations allowed customers to remain in their homes for longer.
 - making progress towards achieving the decent homes standard in the Council owned housing stock by commencing major capital investment programmes
 - improve the number of decent homes in the private sector by making grants available to homes owners toward improving their properties and assist in the Council achieving its decent homes targets

progress in 2007/08 financial year

disabled adaptations to council owned properties

In an area where a large proportion of customers are elderly, it is essential to ensure that those customers can continue to live in their homes comfortably and with ease.

- To assist our customers a total of £275,000 has been spent in 2007/08 in ensuring disabled adaptations have been completed.
- A total of 66 properties benefitted from major disabled adaptation work, this includes items such as level access showers, stairlifts etc. A further 191 customers have benefited from minor adaptation works such as grabrails and ramps. This type of work has directly benefited our customers and has ensured they can live comfortably within their home.
- A one-off scheme in Bishop Auckland a major adaptation for the benefit of a disabled young person by providing a wheelchair accessible single bedroom and shower room. The works costing £35,000 are due to be completed shortly.

disabled facilities grants

Disabled Facilities Grants (DFG's) are essential to assist customers within the private sector to be able to remain in their home as their needs change over time. Central Government allocate an amount in the region of £190,000 per annum to assist in these grants. Including this Government allocation the Council spent £330,000. This has delivered in the region of 85 major adaptation projects.

major repair grants

- In 2007/08 the Council has spent £209,000 improving the living standards for our vulnerable customers. A total of 30 grants have been delivered which has resulted in these properties being brought up to the Decent Homes Standard. The demand for major repair grants are increasing and to better project the extent of the problem a private sector house condition survey is underway.
- The delivery of these grants has seen poor living conditions and standards improved, furthermore customers who have been living in extreme fuel poverty and in a home which is thermally inefficient and prejudicial to health, now live in a property which provides them with a good standard of living.

decent homes

- Dale & Valley Homes brought 244 Council owned properties up to the Government's decent homes standard at a total cost of approximately £3.5 million and within these properties the following elements were replaced:-
 - 186 kitchens
 - 201 bathrooms
 - 83 heating installations
 - 4 boiler only installations
 - 59 full rewires
 - 183 partial rewires
 - 83 lofts insulated

In addition 867 properties received new windows and doors at a total cost of approximately £3.2 million.

proposed 2008/09 programme

decent homes

- The Major Repairs Allowance and additional 'two star' finance for the 2008/09 financial year is in the order of £ 8.9 million to be allocated to Dale & Valley Homes.
- Dale & Valley Homes do not yet have a detailed investment programme for this current financial year however draft proposals are as follows:-

The actual property addresses and proposed works will be presented to a future Housing Sub Committee for approval.

disabled adaptations to council owned properties

17 Council has agreed to set aside £173,800 of resources towards the continuation of the disabled adaptations programme. As previously stated, these works will improve the quality of life to some or our most vulnerable customers. It is anticipated that the volume of work delivered witll be similar to that of 2007/08.

disabled facility grants

A total of £234,000 has been allocated for this financial year, directed towards continuing the private sector and adaptation programme. The Home Improvement Agency will continue to deliver this service on the advice of Social Services

major repair grants

19 Council has allocated £250,000 towards improving living standards of vulnerable customers. This will enable the Council to improve the standard of private housing as well as the quality of life of residents.

equalities and diversity

This report includes alterations and modifications to meet the needs of disabled residents.

human resources

21 There are no implications from this report

consultation

22 Consultation regarding the Dale & Valley Homes' detailed decent homes programme will be undertaken with customers, Dale & Valley Management and the Council.

financial implications

- 23 All 2007/08 schemes as reported fall within the approved capital budget allocation.
- The current year's capital programme has been agreed by Council and the breakdown of costs will be presented to the Housing Sub-Committee when the detailed investment programme is submitted by Dale & Valley Homes.

HOMELESSNESS STRATEGY IMPLEMENTATION GRANT – SPENDING PLANS

purpose of the report

To seek approval of spending plans for the annual Homelessness Strategy Implementation Grant received from Communities and Local Government (CLG).

background and policy context

- Local authorities have had a statutory responsibility to both respond to and prevent homelessness since 1977; however, the Homelessness Act 2002 placed a greater emphasis on the pro-active prevention of homelessness. This statutory responsibility was enshrined in the Council's Homelessness Strategy which aimed to "develop a homelessness prevention culture that delivers a reduction in homelessness and alleviates the harmful effects of homelessness by improving services".
- 2. Since 2002 a number of publications providing guidance have been issued; however, probably the most significant of these was CLG's *Homelessness Prevention: A Guide to Good Practice* in 2006. This guide provides local authorities with advice regarding a number of measures that have been found to help prevent homelessness, including:
 - the provision of housing advice;
 - rent deposit schemes;
 - family mediation services;
 - domestic violence support;
 - assisting ex-offenders and people released from other institutions, and;
 - the provision of tenancy sustainment services.
- 3. In support of this policy direction and to help local authorities introduce some of the measures set out above, the government department responsible for homelessness (currently CLG) has provided the Council with a Homelessness

Strategy Implementation Grant since 2003/2004. For 2008/2009 this grant has been increased by £10,000 resulting in a total grant of £40,000.

current situation

4. Details of how the 2007/2008 grant was used are set out in Annex A. It can be seen from this that the Council already provides access to many of the services recommended by CLG.

proposal

- 5. Details of how the Homelessness Service plans to spend this year's grant, including the additional allocation, are set out in Annex B. If approved these proposals should ensure that access to existing prevention measures is maintained and result in the introduction of the following new measures:
 - rent deposit scheme, which will provide homeless individuals or those at risk
 of becoming homeless with a means of securing a tenancy with a private
 landlord (a separate report which details how this scheme will operate will be
 presented to Committee);
 - a support protocol for care leavers to ensure the specific needs of this group of individuals who are at risk of becoming homeless are addressed in a comprehensive manner, and;
 - a homelessness prevention panel involving staff from the Council and Dale & Valley Homes in order to maximise the number of at risk tenants who are diverted from the homelessness path.
- 6. In addition to these specific measures, the plans to improve the accommodation at Dellside should help to reduce the number of occasions on which individuals have to be housed in B&Bs, which is a further target of CLG.

financial implication

7. The proposals contained within this report will fully account for the Homelessness Strategy Implementation Grant provided by CLG; however, as this is a ring-fenced grant the possibility of utilising it in other ways is not a consideration. Whilst the majority of this funding will be used up in 08/09 to deliver the schemes described, the funding for the rent deposit scheme will be held in an account and only used if any of the individuals we assist subsequently default on their tenancy. Consequently, it is possible that all or some of this funding may be carried forward to subsequent years.

legal implications

8. The proposals set out in this report will ensure that the Council is further fulfilling its statutory obligation to pro-actively prevent homelessness. In addition, the

development of a rent deposit scheme will place an obligation on the Council to fund any costs up to the value of the agreed deposit should an individual default on their private tenancy. Whilst this is a consideration, the deposit scheme will be run in accordance with the best practice guidance issued by CLG and the maximum potential commitment will not exceed the amount allocated to the scheme.

human resource implications

9. The development, implementation and management of the proposals set out in this report will require the commitment of officer time; however, this work can be accommodated within existing resources.

it implications

10. There are no IT implications in relation to the proposals set out in this report.

equalities and diversity implications

11. Those individuals who come into contact with the Homeless Service are often from some of the most marginalised sections of our community. Consequently, given that the proposals set out in this report aim to improve and develop the Council provision in this area, it is likely that they will help contribute to the Council's equality and diversity agenda.

crime and disorder implications

12. There are no direct crime and disorder implications in relation to the proposals set out in this report; however, where homelessness is not prevented there is likely to be an increased tendency towards crime in order to allow individuals to take care of themselves. Consequently, the proposals set out in this report may help stop a small number of individuals entering the criminal system.
