- 1. **THE MINUTES OF THE MEETING OF THE DISTRICT COUNCIL OF EASINGTON** held on 10 January 2008, a copy of which had been circulated to each Member, were confirmed.
- 2. THE MINUTES OF THE EXTRAORDINARY MEETING OF THE DISTRICT COUNCIL OF EASINGTON held on 20 December 2007, a copy of which had been circulated to each Member, were submitted.

RESOLVED that the information contained within the Minutes, be noted.

3. AMENDMENT OF THE EASINGTON DISTRICT COUNCIL BYE-LAWS AND CONDITIONS TO INCLUDE THE SPECIFICATION OF VEHICLE STANDARD FOR WHEELCHAIR ACCESSIBLE HACKNEY CARRIAGE VEHICLES

Consideration was given to the abovementioned report of the Executive Member for Health, a copy of which had been circulated to each Member.

The Executive Member for Health advised that the report sought approval to amend the Council's current bye-laws and conditions to include the specification of vehicle standard for hackney carriages which would be licensed as wheelchair accessible.

The report provided details of the required specification of such vehicles, specified the required training for drivers and sought approval to amend the Authority's current vehicle construction standards to include this additional criteria of vehicle.

The Executive Member explained that additional hackney carriages above the current limit of 93 would be licensed by the Authority if they satisfied the standard specified in the report. The addition of these vehicles to the hackney

carriage fleet would ensure wheelchair users were provided for in day to day taxi usage in the District.

Under the Disability Discrimination Act 1995, the Government had specified a date of 2020 by which all hackney carriages in certain larger authorities must be wheelchair accessible. It was anticipated that once this date was passed, the legislation would be rolled out to all authorities in the country. Implementation of the policy now would pre-empt such a requirement.

Durham County Council currently provided training for drivers contracted for the transportation of wheelchair users. They were prepared to provide the same training for the drivers of wheelchair accessible hackney carriages. The cost of this training would be borne by the driver and would be a requirement for the licensing of such vehicles.

The specification which vehicles must comply with in order to be licensed, was attached as Appendix 1 to the report for Members consideration. The standard had been drawn up taking into consideration reports from the Public Authority Transport Network and the Department of Transport's Ergonomic Requirements for Accessible Taxis.

The Executive Member continued that prior to the meeting, East Durham Hackney Association, through its Secretary, had expressed concern regarding the licensing of rear access vehicles on health and safety grounds. However, as this specification was commonly applied by other Authorities and the vehicles concerned complied with Government standards, they would be licensed at this point in time. The concerns raised by the Association would be forwarded to the Department of Transport. The standard for wheelchair accessible hackney carriages would be re-visited taking into account any comments received from the Department of Transport.

RESOLVED that:-

- (a) the existing bye-laws and conditions be amended to include the vehicle construction specification at Appendix 1 to the report, in respect of wheelchair accessible hackney carriage vehicles;
- (b) the specification of Durham County Council as the appropriate training body for drivers of such vehicles, be approved;
- (c) the concerns expressed by East Durham Hackney Association, be noted and forwarded to the Department of Transport with the standard for wheelchair hackney carriage vehicles revisited taking into account any comments received.
