PROPOSED TEMPORARY ROAD CLOSURE ORDER FOR THE PREVENTION OF OBSTRUCTION OF BEDE WAY, BURNHOPE WAY (PART), PASSFIELD WAY (PART) AND OAKERSIDE DRIVE (PART), PETERLEE ON SATURDAY 30 AUGUST 2008

The Council has been asked by Peterlee Town Council to make an Order under Section 21 of the Town Police Clauses Act 1847. The effect of the Order will be to close the road in four sections:-

- Section 1** Close Bede Way from Peterlee centre to the junction of Burnhope Way from 10.15 am to 10.30 am as coloured red on the plan on display outside the Council Chamber
- Section 2** Close Burnhope Way from the junction of Bede Way to the roundabout from 10.30 am to 10.45 am as coloured yellow on the plan on display outside the Council Chamber
- Section 3** Close Passfield Way from the roundabout to the junction of Oakerside Drive from 10.45 am to 11.00 am as coloured green on the plan on display outside the Council Chamber
- Section 4** Close Oakerside Drive from the junction of Passfield Way to Helford Road show field from 11.00 am to 11.15 am as shown coloured blue on the plan on display outside the Council Chamber

The proposed Order has been suggested to safeguard the public as the parade travels from Peterlee Leisure Centre to the show field in Helford Road. The road will be thronged and liable to be obstructed during the event, hence the necessity to make an Order.

It is intended that the area will be closed off by Marshalls provided by Peterlee Town Council, and that adequate diversion signs will be in place.

Decision Required:

- 1 the Council is requested to hereby make an Order under Section 21 of the Town Police Clauses Act 1847 for the purposes of preventing an obstruction at Bede Way, Burnhope Way (part), Passfield Way (part) and Oakerside Drive (part) on Saturday 30 August 2008 between 10.15 am and 11.15 am as shown on the Plan
- 2 authority is requested to undertake the necessary procedures to bring the Order into effect

PROPOSED TEMPORARY ROAD CLOSURE ORDER FOR THE PREVENTION OF OBSTRUCTION OF NORTH TERRACE, SOUTH CRESCENT, CHURCH STREET, SOUTH TERRACE, NORTH RAILWAY STREET, SIDE STREET BETWEEN 17 AND 18 NORTH TERRACE AND GEORGE ELMY LIFEBOAT WAY ON SUNDAY 27 JULY 2008

The Council has been asked by Seaham Town Council to make an Order under Section 21 of the Town Police Clauses Act 1847. The effect of the Order will be to close the following roads:-

Close North Terrace, South Crescent (part), Church Street (part), South Terrace (part), North Railway Street (part), side street between 17 and 18 North Terrace and George Elmy Lifeboat Way (part) from 8.00 am to 6.00 pm as coloured orange on the plan on display outside the Council Chamber

The proposed Order has been suggested to safeguard the public as the parade travels from North Terrace to the Terrace Green. The road will be thronged and liable to be obstructed during the event, hence the necessity to make an Order.

It is intended that the area will be closed off by Marshalls provided by Seaham Town Council, and that adequate diversion signs will be in place.

Decision Required:

- 1 the Council is requested to hereby make an Order under Section 21 of the Police Clauses Act 1847 for the purposes of preventing an obstruction at:-

North Terrace, South Crescent, Church Street, South Terrace, North Railway Street, side street between 17 and 18 North Terrace and George Elmy Lifeboat Way on Sunday 27 July 2008 between 8.00 am and 6.00 pm as shown on the plan

- 2 authority is requested to undertake the necessary procedures to bring the Order into effect

7 **Town and Country Planning Act 1990 Section 257 – Public Footpath Stopping Up and Diversion Order
The District of Easington (Pembroke Place, Peterlee) (No 1) Public Path Stopping Up and Diversion Order 2008**

As a measure to help resolve serious anti social behaviour issues, planning permission for the erection of fencing, installation of a new footpath and change of use of highway land to private garden at Pembroke Place, Peterlee was approved by the District Council on 25 May 2006.

The District Council is now requested to make an Order under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to stop up and divert the footpaths to which this order relates to enable development to be carried out in accordance with planning permission granted.

A copy of the Order and Order map is attached which shows the footpaths to be stopped up and diverted as part of this order.

Accordingly, the District Council is hereby requested to make the District of Easington (Pembroke Place, Peterlee) (No 1) Public Path Stopping Up and Diversion Order 2008 and to authorise the Council's Governance and Risk Manager to undertake the necessary statutory order procedures.

8 **Town and Country Planning Act 1990 Section 257 – Public Footpath Stopping Up
The District of Easington (Unnamed Footpaths at St John Square, Seaham) Public Path Stopping Up Order 2008**

As a measure to compliment the outline planning approval to provide a multi-use public service centre, office space, residential, retail and health care

provision and public square, a new public footpath will improve access across the site and meet the aesthetic quality of a comprehensive redevelopment.

The District Council is now requested to make an Order under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to stop up the footpaths to which this order relates to enable development to be carried out in accordance with planning permission granted.

A copy of the Order and Order map is attached which shows the footpaths to be stopped up.

Accordingly, the District Council is hereby requested to make the District of Easington (Unnamed Footpaths St Johns Square, Seaham) Public Path Stopping Up Order 2008 and to authorise the Council's Governance and Risk Manager to undertake the necessary statutory order procedures.
