## **1.** Purpose of Report

## 4. Policy, Financial, Legal and Risk Implications

## 4.1 **Policy Implications**

- 4.1.1 It has been the policy of the Council for the Chair and Vice Chair of the Council, at the time of the individual visits, together with the Twinning Officer to attend on these occasions. In addition approval has also been given for the Chief Executive and Members of the Management Team to visit Baesweiler in order to generate closer links with counterparts in and around Baesweiler and to gain an insight into service provision in Germany.
- 4.1.2 It was agreed that the Director of Community Services participate in the Kirmes 2006 visit but due to a family bereavement he was unable to attend. It is therefore suggested that the Director of Community Services participate in the 2007 Kirmes visit to Baesweiler on behalf of the Chief Executive and that a number of study visits relating to street cleaning, refuse, recycling, community safety and leisure be built into his programme.

## 4.2 **Financial Implications**

4.2.1 There are no financial implications as a budget provision is in place to cover existing

policy. Funding to cover any additional attendees is found from existing departmental budgets.
