## **1. Purpose of the Report**

- 1.1 To seek approval of the District of Easington Scrutiny Annual Report 2007/8.

- 4.1 The proposed Annual Report details the work of the Council's Scrutiny function undertaken by the three Scrutiny Committees and overseen by the Scrutiny Management Board during 2007/08.
- 4.2 The report has been produced jointly on behalf of the Scrutiny Committees and aims to demonstrate the principle that the Scrutiny Committees work together in ensuring that they complement the strategic work of the Executive and that the corporate priorities and performance targets agreed by the Council are met.
- 4.3 The report:-
- I. details the principles behind effective scrutiny within the Council
  - II. highlights the co-ordinating role of the Scrutiny Management Board and how it has developed its formative role in respect of policy development and service review.
  - III. reviews the work undertaken by the Scrutiny Committees during 2007/8.
  - IV. sets out the proposed areas of work which form the new Scrutiny Committees' Work Programmes for 2008/9.
  - V. highlights areas of further developments in Scrutiny that the Committees will face during the coming year.
- 4.4 This Annual Report highlights the work undertaken by the Community Services, Resources and Regeneration Services Scrutiny Committees during 2007/8.

- 4.5 The Annual Report also sets out the proposed areas of work that will form part of the Committees' work Programmes for 2008/9 and are drawn from the Council's Corporate Plan and Transitional Plan which detail key Council Priority areas of work over the coming year.
