- 1. **THE MINUTES OF THE LAST MEETING** held on 4 November 2008 a copy of which had been circulated to each Member, were confirmed.

# 2. GENERAL FUND/HOUSING REVENUE/CAPITAL FINANCE - 2008/2009 MONITORING STATEMENT

Consideration was given to the report of the Executive Member for Resources which gave details of the financial position for the period 1 April to 30 September 2008, a copy of which had been circulated to each Member.

Members were advised that budget holders were required to carry out a monthly exercise of examining their spending and the appendices attached to the report reflected the forecasted position to 30 September 2008.

The Director of Finance and Corporate Services outlined in detail the position on the General Fund, Housing Revenue Account and Capital Programme.

**RESOLVED** that approval be granted to;

- (i) utilise the surplus on the HRA to finance the Capital Programme related to decent homes and other ALMO works,
- (ii) transfer £200,000 from the Support Service Reserve to the Regeneration Reserve,
- (iii) utilise £130,000 from the Support Service Reserve to establish a specific reserve to complete the Apollo Pavilion project (£15,000), Works at Easington Colliery (£30,000) and to ear mark £85,000 as a council contribution to the play strategy, (Play Strategy/Apollo Reserve/Minor Works),
- (iv) transfer £1,500,000 from the Management of Change Reserve to the Regeneration Reserve,
- (v) transfer £250,000 from the Planning Delivery Reserve to the Regeneration Reserve.

#### 3. **EXCLUSION OF THE PRESS AND PUBLIC**

**RESOLVED** that in accordance with Section 100A (4) of the Local Government Act, 1972 as amended by the Local Government (Access to Information) Act, 1985 the press and public be excluded from the meeting for the following item of business on the grounds that it involved the disclosure of exempt information, as defined in Paragraph 3, Part 1 of Schedule 12A of the Act.
