#### AF(2)2/05 MINUTES

The Minutes of the meeting held on 19<sup>th</sup> April 2005 were confirmed as a correct record and signed by the Chairman. (For copy see file of Minutes).

#### AF(2)3/05 POLICE REPORT

Sergeant K. Vincent and Inspector A. Green were present at the meeting to give details of the crime figures and local initiatives for the area.

Insp A. Green explained that he had recently taken up post to replace Insp Winship. He explained that he had been in service with Durham Constabulary for 15 years with an operational background.

The Forum was given details of a number of operations and initiatives that were ongoing throughout the area.

It was explained that a new PCSO had recently been appointed to assist the Beat Team and increase the numbers of patrols during the summer months to target any anti social behaviour.

Members were also informed of the procedures for holding events on the public highway. It was explained that there was strict legislation that needed to be followed. Organisers should consult with Durham County Council, Durham Constabulary, Sedgefield Borough Council and a Traffic Management Company in order for the event to be carried out correctly and safely.

Members expressed concern at the criminal damage that had been caused to a number of allotments, greenhouses and newly planted trees around the area. Sgt Vincent explained that the matter was being looked into and that the Town Council was considering the development of an allotment watch.

Concerns were also raised regarding the number quad bikes that were being misused and what powers the police had. It was explained that the police would talk to the owners to deter them from using the bikes in public areas and that they also had powers to seize the bikes if their advice was not taken and registration documents were not provided.

Cards detailing the new non-emergency contact number for the police were distributed to the Forum.

#### AF(2)4/05 SEDGEFIELD PRIMARY CARE TRUST

Dr. A. Learmonth and Mrs. S. Slaughter were present at the meeting to provide an update on local health matters and performance figures.

Detailed discussion was held regarding the progression of the Health Care Centre at Chilton. The Chairman of the Forum informed Members that she had received a letter from G. Wills, Chairman of Sedgefield Primary Care Trust to assure the Forum that the Health Care Centre would be developed and was constantly being reviewed.

Mrs. S. Slaughter informed the Forum that funds had been released by the PCT in April to begin the process of purchasing the land. It was then agreed in May that the development was to be given the full go ahead. It was also explained that a feasibility study would be taking place in July to be completed in September and would consider all aspects of the development. Once that was complete a Business Case would be implemented to progress the development further.

Members expressed concern at the length of time the development was taking, pointing out that there were still problems in making appointments with a doctor and that people were continuing to find it difficult if it was necessary for them to travel to Ferryhill.

Dr Learmonth gave a presentation detailing the Director of Public Health Annual Report 2004/05 'The Health and Wellbeing of People in Sedgefield.' Copies of which were distributed at the meeting.

The presentation gave details of the Structure of the report, its 4 main aims, new features, the agencies who contributed to the development of the report, local statistical information and the priority areas.

Dr. Learmonth distributed the Board Report, 9<sup>th</sup> June 2004 detailing performance figures, making specific reference to the problems in meeting the target for the ambulance response time. Questions were raised as to whether satellite navigation could be installed in the ambulances, and what ways local knowledge could be developed to aid in the response time improving. It was explained that all concerns and comments would be taken back to the relevant Officers at the PCT for consideration.

It was also explained that the Local Delivery Plan 2005/2008 had been agreed. More information would be brought to the next meeting.

Detailed discussion was also given to ways of improving services, the practice based commissioning service, the progress of the Integrated Teams and the investment that had been made in developing the services for those suffering from mental health problems.

REPORT TO AREA 2 FORUM

6<sup>th</sup> September 2005

#### REPORT OF HEAD OF STRATEGY & REGENERATION

#### CHURCH LANE CAR PARK, FERRYHILL

#### 1.0 **SUMMARY**

- 1.1 Sedgefield Borough Council is the owner of Church Lane car park, Ferryhill. For some time now, there has been concern at the lack of usage of the Church Lane car park, which, the consensus is that, it is linked to the congregation of young people and ongoing reports of anti social behaviour.
- 1.2 A number of potential solutions have been considered in the past, however, agreement about which option best addresses the problems without being detrimental to the amenity of local residents has been difficult to secure.
- 1.3 The Borough Council wishes to consider the options in conjunction with residents and interested parties, with a view to implementing an improvement scheme during 2005/6.

#### 2.0 **RECOMMENDATIONS**

2.1 In light of the information provided, the Area forum is requested to indicate its preferred option to address the problems associated with the Church Lane car park.

#### 3.0 BACKGROUND

- 3.1 Ferryhill Town Council has conducted a consultation exercise, with those residents surrounding the Church Lane car park in Ferryhill town centre, following complaints from residents regarding anti social behaviour and criminal damage to cars in that car park. Ferryhill Town Council subsequently requested that the Borough Council take action to improve the security of the car park in Ferryhill town centre accessed from Church Lane. The Borough Council conducted a survey of spaces available within the Market Place car park and found that although the car park was busy at various times of the day there were a few spaces available for use. A summary of the responses to the Town Council's survey is attached as Appendix 1, and the SBC survey details as Appendix 2.
- 3.2 This car park is currently underused. It is reported that residents and potential users fear that their vehicles will be stolen or damaged while

parked, even for a short time, in this car park. This places pressure on the Market Place car park in Ferryhill during the day. The Church Lane car park is reluctantly used on Fridays when the weekly market occupies the Market Place car park.

- 3.3 Complaints have been received by the Town Council from businesses and residents about perceived security/safety problems linked to youths congregating in the Church Lane car park. Businesses are also concerned that they are losing business because of the lack of usable parking spaces. The residents complain that town centre users park their vehicles in the residential areas if the Market Place car park is full rather than use the Church Lane car park.
- 3.5 A number of options have been discussed, however, there is currently no consensus over the way forward.

#### 3.6 **OPTIONS**

- a. **Improve the lighting.** This option will discourage the use of the car park as a location for anti social behaviour by illuminating the activities of the youths congregating there. This does not increase natural surveillance but if used in conjunction with CCTV could improve conditions for residents.
- b. **Reduce height of wall ad install railings.** To reduce the height and install railings to the top of the wall will allow for natural surveillance of the car park by local residents thereby discouraging use of the car park by youths. Most responses to the Town Council's survey state this is a good idea, although there is some concern by residents over the lack of police response to calls regarding anti social behaviour there.

Although professional thought there would be, residents did not report that the intrusion of light into their homes from car headlights would be a problem. This is yet to be tested.

There has been one response identifying the concern that youths currently sit on the car park wall and look into residents' homes. Installation of railings on a reduced wall would solve this problem.

The wall to the car park is a historic random rubble wall that leads to a listed building, St Luke's Church. Bearing in mind that the wall is historic and has been repaired in the past, it does not have any structural problems, the character of the wall has not been removed. The wall itself is not listed, however, if it is reduced in size this will mean that as a random rubble wall it will be more costly to do, requiring expertise. c. **Installation of a CCTV camera.** Most responses suggested that CCTV would be a popular option for residents viewing this as a panacea for the current problems being experienced. The cost of this option will include the installation of the equipment costs of monitoring and maintenance for which the Borough Council would be liable. This could mean this option is dependent on the Borough's ability to accept the ongoing maintenance costs.

The proximity of the CCTV camera to residential properties may contravene privacy legislation. This would need to be investigated.

d. **Do nothing.** In light of the ongoing concerns from residents and other local people it is appears that there is a desire to see some form of improvement, and reduction in anti social behaviour. As such the views of participants at the Area Forum will determine whether or not 'To Do Nothing' is a practicable option.

#### 4.0 **RESOURCE IMPLICATIONS**

4.1 The Regeneration Services Capital Programme budget allows spend up to a maximum of £20,000.

#### 5.0 CONSULTATIONS

5.1 Consultation has taken place with: residents, Ferryhill Town Council (results attached as Appendix 2), the Area 2 Forum, the Strategy and Regeneration Capital Programme Working Group. Once a decision has been made by the Area 2 Forum residents will be advised of the proposals and timescales for work to commence.

#### 6.0 OTHER MATERIAL CONSIDERATIONS

- 6.1 The likely timescale for these works to be completed will be March 2006 as considerations must include planning, and tendering processes.
- 6.2 Each of the above options on their own are likely to improve the quality of life of local residents who are currently suffering from the anti social behaviour of the youths congregating in the car park thereby reducing crime in that locality.

#### 7.0 OVERVIEW AND SCRUTINY IMPLICATIONS

7.1 The chosen option and associated works as part of the Strategy and Regeneration Services Capital Programme will be subject to the normal Overview and Scrutiny Arrangements.

When my family come to stay they find difficulty parking in front of my house. There should be no double parking. Buses were stopped using Church lane some years ago.

Railings will not stop youths using this to do wheelies and skids. Also youths aged 15 upwards from Dean Bank playing football until dark from 3 p.m. onwards.

Why does the Town Council seem so interested in this venture when the car park belongs to the District Council. If you would like people to use the car park more make church lane Residents Only parking.

Have the police vacate the local fish shops and get on the streets and tackle the hooligan problem so evident in this town; instead of two of them walking away from a gang of yobs playing football and at times hurling abuse at passers-by, as they did on one day last week (in the car park, that is).

How about installing a CCTV camera linked to the same system as the rest of the town centre. This would probably cost the same but would be much more of a deterrent.

# CAR PARK IN FRONT OF TOWN HALL AND TO THE REAR OF NAT WEST BANK, FERRYHILL TOWN CENTRE

Thank you for your letter of 22 May 2003 in response to my earlier letter of 15 May.

Please accept my apology for the delay in responding further but this has been due to our conducting of a survey of the car parking situation within Ferryhill Town Centre to obtain a more informed analysis of the current situation.

The survey consisted of recording the use of the various car parks within the Town centre over a five-day duration between the hours of 12 and 2pm. A copy of our findings is attached for your information including some photographic record.

From this it would appear that on each occasion there have generally been adequate vacant spaces available. On this basis I would observe that perhaps the case for a lack of parking spaces within the central car park and the surrounding roads is not as clear cut as initially suggested by the Chamber of Trade and your Council. It would also appear that the car park at the rear of the Nat West Bank predominantly operates as an overspill car park, particularly on Friday when the weekly market occupies the central car park.

In view of the above situation and my initial appraisal of the environmental loss to the street scene by a reduction in the height of the wall between the car park and Church Lane, I feel at this point unable to recommend that the Borough Council commit resources to such a scheme. However, I would be pleased to discuss the matter further with you when you have had the opportunity to fully consider the results of our research into the car parking issues in Ferryhill Town Centre.

## Re: Car Park to the rear of Nat West Bank, Ferryhill, Co Durham & to the rear of Blamires Printers, Ferryhill

At a recent Chamber of Trade meeting a large amount of concern was expressed with regards to the car parking provision within the town of Ferryhill. Members are particularly concerned at the lack of parking available in the Town Centre car park provided by the Town Council as many vehicles are left to park there all day this causes a problem for people who wish to call into the Town Centre quickly to buy produce etc. and is possibly putting them off from using the shops in the Town Centre altogether. It also results in many unscrupulous drivers abandoning their cars illegally in front of the shops. As a means of combating this Members have discussed the idea of using a disc scheme for the Town Centre Car Park to limit parking here to a maximum of 2 hours however before doing so they felt that some improvements needed to be made to alternative car parks before users of the Town Centre are forced to use them.

To this end we are currently exploring the possibility of providing some CCTV coverage for the car park to the rear of the Nat West Bank however in addition to this and possibly as a cheaper means of improving security Members wondered if it would be possible to reduce the height of the wall on the southern boundary of the car park and to replace it with railings to increase the natural surveillance for this area. I should therefore be obliged if you could look into this matter for me at your earliest convenience.

With regards to the second car park provided by Sedgefield Borough Council to the rear of Blamires Printers Members expressed concern at the poor line markings and the poor maintenance standards around this area where the weeds etc. have been allowed to become overgrown. I wonder therefore if you could forward this correspondence onto the appropriate Officer to ensure that this matter is looked at with a view to rectifying the problems for this unsightly car parking area.

I am writing to you in response to a number of complaints being made to me in my role as the community Police Officer for Ferryhill concerning the problem of anti social behaviour in the Natwest car park at the rear of the Market place in Ferryhill.

I have monitored the situation over a period of a month and I can confirm that there is a problem with regards to youths acting in an anti social manner in the above mentioned area. These actions include under age drinking, minor acts of vandalism, and the smashing of glass bottles.

Anti social behavior is a problem at present in Ferryhill and is an area where we need to work together to find solutions. I am fully aware that the Town Council is committed to working with the Police in reducing the fear of crime and I believe that there is a solution to this problem that currently exists.

The car park at the rear of the Natwest bank is currently a car park that is not used by motorists, this is mainly due to local residents believing that the area is **unsafe**. The car park is surrounded by a high brick wall and the lighting is extremely poor, visibility into the area is none existent and there is no cctv overlooking the area. In my opinion I can understand the fears of drivers parking their vehicles in the area and can also see that the abandoned car park is an ideal site for local youths to congregate and cause acts of anti social behaviour.

I have looked at a number of options and I know believe that a solution to the problems would be to lower the wall around the car park thus making the area visable to all persons around or nearby the area. The response I believe would eliminate the majority of problems in the area, both parking and acts of anti social behaviour. To ensure the safety of the car park I would also suggest an increase in lighting and if possible cctv.

Please bring this letter to the attention of the local council because I believe that by working together on this issue we can reduce the fear of crime to the community surrounding the car park and also make use of a currently under used piece of land.

#### RE. PROPOSED LIMITED WAITING ORDER MARKET PLACE CAR PARK, FERRYHILL

I refer to your consultation dated 25<sup>th</sup> February, 2004, relative to a proposal by Ferryhill Town Council to introduce limited waiting on Ferryhill Market Place about which we comment as follows.

We understand that there is a concern about security in relation to the use of the National Westminister Bank car park. This issue should therefore be addressed in order that motorists are confident in using this car park and that car crime does not become a reality.

In relation to the proposal for limited waiting on the market place we would not be in a position to 'Police' this restriction. However we take the view that if you do introduce restrictions that they should be 'policed'. Not to do this effectively can lead to abuse not only of this specific restriction but of surrounding restrictions as most motorists will not be aware of the different authorities responsible for the restriction.

We also note that you make no mention of when the restrictions would apply, for example: 8am-6pm weekdays etc. as we are also aware that on Market Day the stall holders park all day. You also make no mention of disabled motorists who if not encouraged to park elsewhere can 'legally' park on yellow line waiting restrictions without contravening those restrictions. However as you will appreciate this can cause other problems.

#### Re: Nat West Car Park Provision within Ferryhill Town Centre

Further to previous correspondence with regards to the above please find attached herewith a comprehensive survey undertaken recently by Ferryhill Town Council into the car provision within the Town Centre area of Ferryhill.

The contents of this survey were discussed by the Ferryhill Chamber of Trade recently and they feel it confirms fears they have previously held that currently a barrier exists to increase trade within the Town Centre due to poor security around the Nat West Car Park owned by yourselves. This view has been confirmed by both the Town Centre Manager from Sedgefield Borough Council and the local police as well as Ferryhill Town Council.

Members are very concerned that the current condition of the car park means that shoppers who visit the Town Centre and cannot park either in the Market Place or in the adjacent streets are not stopping in the Town Centre and are therefore not using the local retailers. This clearly has an impact on the future viability of the retailers and the Town Centre as a whole.

Members of the Chamber of Trade have therefore asked that I write to yourself and request that you look into this matter urgently with a view to replacing the existing high wall around the car park with railings in order that the natural surveillance and thereafter the security around the car park is

improved. Their views were confirmed recently when the car park was a subject of a criminal damage incident in that a car was vandalised and totally destroyed beyond repair without the knowledge of the local residents. This car was subsequently removed by Sedgefield Borough Council.

#### Re: Car Parking Problems Market Street and Chapel Terrace

Thank you for your recent letter with regard to the above, the contents of which I note.

Ferryhill Town Council, the Ferryhill Chamber of Trade and the Ferryhill Road Safety Working Group have all raised similar queries with regard to this problem with Sedgefield Borough Council, as all bodies believe that the car parking problems in the Market Place and in the Market Street and Chapel Terrace area would be substantially alleviated if the car park to the rear of the Natwest Bank was made more user friendly than it currently is.

As you are no doubt aware during the week almost no vehicles park in this car park, which is capable of holding approximately 50 vehicles, and has been described by the local police as a potential crime haven as there is no natural surveillance on this site with the high walls enclosing it.

Accordingly, the above bodies have all requested that Sedgefield Borough Council reduce the height of the wall and replace it with railings so that the vehicles inside the car park can be observed by the houses adjacent and passers by, thus increasing the natural security of the car park. However, Sedgefield Borough Council has refused to do this, as they state there is not a car parking problem in Ferryhill.

I will, however, forward a copy of your letter and petition to the relevant Officer at Sedgefield Borough Council in order that they can be made aware of the problems you are suffering from due to the lack of parking provision in the town centre, as well as local businesses who feel that the town centre car park is currently beyond operational capacity as this is having an adverse effect on their trade.

I will, however, forward your petition to Sedgefield Borough Council and request that they again review the policy of taking no action to make the Natwest car park user friendly.


With regard to the introduction of a Traffic Regulation Order to make this area for residents only parking the difficulty with this is that generally speaking such orders are only implemented where there is a pay and display car park, which in turn finances the provision of car park attendants who enforce the residents parking zones. However, in the absence of a pay and display car park in Ferryhill there is no revenue to finance car park attendants to police any residents parking zone. To introduce a zone without any means of enforcing it would possibly have an impact in the short-term, but once it became known that the residents zone was not enforced its effectiveness would be far less.

I am also aware that as you state the vehicles that park in your area belong to people that work in local businesses many of the Members of the Chamber of Trade have said that once the Natwest car park is made user friendly they would require all of their staff to use this area to park in as an alternative to the Market Street car park and on street parking which they currently use.

I hope therefore you can see the proposals put forward to make this car park safer should help alleviate the problems that you are currently encountering.

If you wish to make any comments on this, please do not hesitate to write to me again, in order that I may relay this back to the Road Safety Committee and the Ferryhill Chamber of Trade, as well as the Town Council. I look forward to hearing from you at your earliest convenience.



### RE : CAR PARK - CHURCH LANE, FERRYHILL.

The Council has received several reports of vandalism to cars and previously recycling bins within the enclosure of the car park off Church Lane, Ferryhill. The wall, to the south side of the car park, adjacent to Church Lane, is elevated above the footpath level, thus obscuring the observation of any misbehaviour taking place. Vandalism is therefore not discouraged by exposure and the risk of being witnessed.

In the interests of public safety, and to discourage acts of vandalism, the Borough Council are therefore considering reducing the height of the wall on the south side of the car park to approximately 0.3m (1'-0") above the car park surface level, and mounting a 1.2m (4'-0") high metal vertical railing fence (painted black) on the top of the wall. This will hopefully discourage any misbehaviour within the car park, as the area will be clearly visible to residents and passers by.

#### Section 17 Crime and Disorder Act 1998

Miscellaneous and supplemental

Duty to consider crime and disorder implications. 17. - (1) Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

(2) This section applies to a local authority, a joint authority, a police authority, a National Park authority and the Broads Authority.

(3) In this section-

"local authority" means a local authority within the meaning given by section 270(1) of the Local Government Act 1972 or the Common Council of the City of London;

"joint authority" has the same meaning as in the Local Government Act 1985;

"National Park authority" means an authority established under section 63 of the Environment Act 1995.

As can be seen from the attached documents the reasons for the repeated requests by Ferryhill Town Council, Ferryhill Chamber of Trade, Ferryhill Road Safety Group and the Local police to reduce the wall height do have some commonality and can be summarised as follows.

- 1 The main Market place car park is constantly full; a lot of the users are there all day.
- 2 This has an impact on the local traders as many visitors can not get parked and therefore do not stop to trade and do not return.

- 3 Many instances of illegal double parking occur in Market Street Causing a traffic hazard.
- 4 Many car owners prefer to park in front of residential houses in Church Lane and Market Street rather than in the Nat West car park causing residents inconvenience.
- 5 The Chamber of Trade and Town Council would like to introduce limited waiting of 2 hours in the Market Place car Park, but are reluctant to do so until the wall surrounding the Nat West Car Park is removed thus creating natural surveillance to car users there and preventing the above problems being exasperated by such an action.
- 6 The Car Park currently suffers from numerous incidents of anti social behaviour and crime, thieves operate there and have used the hidden location to access nearby shop premises illegally, vehicles have been broken into and vandalised on more than one occasion vehicles have been burnt out completely. I am aware that concerns have been raised about this problem at a recent Crime reduction Partnership, Helen Stewart is pursuing this matter further I believe.

Of course in addition to the above Sedgefield Borough Council have a duty to apply Section 17 CDA 1998 to all their services.
