AF(3)33/07 MINUTES

The Minutes of the meeting held on 27th February, 2008 were confirmed as a correct record and signed by the Chairman. (For copy see file of Minutes).

AF(3)34/07 POLICE REPORT

Sergeant B. O'Connor was present at the meeting to give details of crime statistics in the area.

It was reported that the crime statistics were as follows :-

Discussion took place in relation to anti-social behaviour. It was pointed out that although levels of crime were low, anti-social behaviour remained an issue.

It was pointed out that the Police had received 36 complaints relating to anti-social behaviour in Fishburn. A number of these complaints related to a newly created play area.

Reference was also made to anti-social behaviour at Skerne Avenue/Hart View in Trimdon Village where youths had been throwing stones at properties. Members of the public were encouraged to report incidents to the Police.

The Forum was informed that patrols involving drug dogs had been carried out in public houses in Sedgefield and the Trimdon area. Although no arrests had been made historically patrols involving drug dogs had positive outcomes.

Reference was made to the dumping of tyres between Fishburn and Bishop Middleham. It was explained that A. Denholm, Environmental Protection Officer, was investigating this issue.

AF(3)35/07 WORK OF THE SPORTS FORUM

G. Cooper, Sports Development Officer, was present at the meeting to discuss the work of the Sports Forum.

It was explained that the Sports Forum involving Sedgefield, Fishburn and the Trimdons was the latest sporting hub to be established and enabled agencies to work in partnership to provide sporting facilities for young people.

Specific reference was made to a Cycling Club in Trimdon Village. It was explained that the Sports Forum had enabled the Cycling Club to meet with a similar club in Ferryhill. The Clubs now worked together for the benefit of local people.

It was noted that the Cycling Club in Trimdon Village had limited storage for equipment and had requested that the Club be given use of a vacant garage in Laurel Crescent, Trimdon Colliery. Reference was made to a mapping exercise that had been carried out identifying sporting facilities throughout the Borough. It was explained that this was an ongoing exercise and would be updated on a regular basis.

In response to a question raised regarding membership of the Sports Forum it was explained that all sporting groups, including brownies and scouts, could be involved.

Members of the Forum highlighted the need to publicise sporting activities in the area to encourage participation.

AF(3)36/07 QUESTIONS

Planning Appeal – Land West of Hardwick Park, Sedgefield

Reference was made to a letter received by Sedgefield Residents Forum from Sedgefield Borough Council regarding a request made by Sedgefield residents to work in partnership with the Borough Council in relation to the planning appeal for the siting of 330 static caravans and 47 lodges on land west of Hardwick Park.

A representative from Sedgefield Residents Forum was present at the meeting and expressed disappointment in the response from the Council.

CAVOS Funding

It was noted that CAVOS had received additional funding which would enable more work to be carried out across the Borough.

Report of the Assistant Chief Executive

Sedgefield Borough Local Improvement Programme

Application - Ceddesfeld Hall – Enabling and Extending Community Access

This report highlights a Local Improvement Programme (LIP) application submitted to and initially appraised by the Strategy and Regeneration Section. The report provides information to the Area 3 Forum for their consideration and comments, which will be used to further develop the project proposal prior to it being taken through Sedgefield Borough Council's decision-making process.

The Area 3 Forum has been allocated \pounds 532,000 of LIP capital resources between 2006 and 2009 subject to budget approval. Projects to the value of \pounds 267,681 have been approved to date.

Project Background

- **Name of Project:** Ceddesfeld Hall Enabling and Extending Community Access
- Name of Applicant: Sedgefield Community Association
- Brief Description of Project: The project will enhance the existing facilities and open up disused and underused spaces in the first floor, attics and basement, all of which will become available for public use. The first phase, to which this application relates, involves the installation of a lift to all levels, a new IT facility, IT education in the community provision, refurbished toilets and new office accommodation for the neighbourhood warden and the association.
- Requested from LIP: £103,000 (48%)
- Total Estimated Project Cost: £210,500

• Impact of the Project:

The applicant has stated that the population of the town is getting progressively older. At present, mums with young children and those with mobility problems can only take part in activities and groups which meet in the main hall / function room which socially excludes a proportion of those living in the area of benefit. The first floor has 3 rooms all of a similar size accommodating 25-30 people. This project will give added value to the existing provision, offer new opportunities for groups and individuals who are currently not catered and will in turn help in protecting the longevity of the association.

• Evidence of need and community support:

The applicant has stated that the project links to the Sedgefield Town Council community appraisal, town plan and police reports. They have also stated that the youth form and youth council are seeking to address services and facilities for young people. The applicant has also stated that SCA lettings and booking evidence the need for the project. Wider community consultation is ongoing at the moment.

• Value for money and Revenue implications:

The applicant has applied for £103,000 which is 48% of the total project costs for phase 1. The remaining capital costs will be funded by funds from various funders including SCA own funding, Gannet Foundation, Sedgefield Town Council and Sedgefield Charities. The majority of the other funding is yet to be confirmed.

• Statutory Approvals:

Planning Permission and Building Regulation consent will be required. This will become a condition of any grant approved as the costs of producing planning application compliant plans are included in the costs for phase 1.

Recommendation from the Strategy and Regeneration Section:

That the Area Forum considers:

• The project proposal, and how it would meet the priority needs of the Area 3 Forum locality.

Subject to discussion and agreement by the Area Forum to progress the project proposal, the applicant will work with the Strategy and Regeneration Division to further develop the LIP application prior to it being taken through Sedgefield Borough Council's decisions making process.
