CP HC 1.1	We are working in partnership with Macmillan Cancer Support and the NHS to support six health information points in our libraries. These provide relevant information for those recently diagnosed with cancer, their relatives and carers. This initiative is to be supported by an active marketing campaign to increase book use of 2000 loans by September 2008				There are 6 health information points in libraries across the County, supported by Macmillan Cancer Support and the NHS. The target of an increase of 2000 health book loans by September was achieved with an increase of 2,686 loans. From April to December 2007 there were 41,363 health book loans, compared to 43,902 from April to December 2008 - this is an increase of 2,539 (6.1%).	
CP HC 1.2	We will work with partners to establish a Health and Wellbeing Partnership by April 2008. This will provide new opportunities for us to agree with partners what is important for the County's health and wellbeing and how we will work together to achieve outcomes.
