INTRODUCTION TO THE DISTRICT OF EASINGTON'S FORWARD PLAN OF KEY DECISIONS

This is the Forward Plan of key decisions which the District of Easington is required to update monthly in accordance with the Local Government Act 2000.

Key decisions are defined by statute as:

- (a) Decisions likely to result in the Council incurring expenditure which is, or the making of savings which are, significant having regard to the Council's budget for the service or function to which the decision relates; or
- (b) To be significant in terms of its effects on communities living or working in an area comprising two or more wards or electoral divisions in the area of the Council.

The Forward Plan is updated monthly and includes the key decisions to be taken by the Executive for the following four months. The updated Forward Plan for each month will be available fourteen days in advance of the date that it comes into effect (which will be on the 1st of the month).
