**1 CARERS COLLABORATIVE**

Liz Allan, Patient and Public Involvement Co-ordinator and D Robinson from the Carers Collaborative were in attendance to give an update in relation to Easington Carers Collaborative.

D Robinson commenced by providing a background to the Collaborative which had been borne out of a number of organisations to assist carers. Carers issues had become more prominent in recent years with recognition of the role the carer played in society and the way in which carers saved the public money and resources. The Government estimated that for every £1 spent on carers £10 was saved.

The 2001 census recognised that there was 5.2 million carers in England and Wales with the North East having the highest proportion of carers at 11%. In Easington from a population of 93,993, the total number of carers was 11,964, the highest in the North East. Of these carers 3,674 cared for more than 50 hours per week. Easington District Carers support had currently 922 registered carers.

One of the aims of the Collaborative was to reach new carers and in doing this raise their profile. Leaflets and posters were not always read wherever they were placed, other ways of advertising were expensive and it had been shown that the best way of reaching new carers was by personal recommendation.

He gave details of events that had been held in the past year which included a Carers Week Dance at Shotton Hall in June 2004 and the Carers Collaborative Day at Vane Tempest in November 2004. These had been extremely successful and the Collaborative wished to repeat the events again in 2005. To achieve this the support of each member organisation was necessary.

It was suggested that an article be placed in Infopoint highlighting the work of the Collaborative and the number of carers in Easington. D Robinson added that work had been undertaken with the Council's Communication and Marketing Section to raise awareness of the events.

To conclude, L. Allan stressed the need for continuous support from partner organisations to ensure the success of the collaborative's aims.
