5. BACKGROUND, POSITION STATEMENT & OPTION APPRAISAL

- 5.1 The County Durham Scrutiny Member Network conducted a major review into Local Transport. The review began in July 2007 and was concluded in March 2008.
- 5.2 Recent Governments have not sought to reverse the deregulation of the bus industry brought about by the Transport Act 1985, the current

Version 1.0 June 2008 Report to P&P OSP 18 June 2008 Government has recognised, in "Putting Passengers First" (2006) and the Local Transport Bill (2007), that transport services (primarily buses) should meet the needs of all and that vulnerable people in society are not isolated because of difficulties in accessing transport for everyday needs.

- 5.3 It was these actions that provided the impetus for this scrutiny project, undertaken by Councillors from the seven District Councils and Durham County Council. Members wished to enhance their knowledge about the levels of transport provision across the County; the challenges faced by providers; and the needs of users. There was also a desire on the part of members to identify where opportunities might exist for services to be improved and to make recommendations, where appropriate, linked to these issues.
- 5.4 The review team gathered a lot of information and evidence throughout the review process and this has been collated and presented in the report attached at appendix 1 of this report.

6. **RECOMMENDATIONS**

- 6.1 That Members note the review and provide comments and amendments as appropriate.
- 6.2 That Members agree to the recommendations contained within the report following any additions, deletions or amendments.
- 6.3 That Members of the Panel agree that the report be presented to the Executive following amendments.
