


### Why we should Recycle Environmental Sustainability



- Landfill Sites Greenhouse Gases
  - 50% of emitted methane comes from landfilled waste
- Energy Conservation
  - Re-processing recycled aluminium cans saves 95% of the energy it would take to make them from bauxite
  - Reprocessing one plastic bottle saves enough energy to power a 60W light bulb for 6 hrs
- Natural Resources
  - Reduced demand on virgin materials
  - Recycling steel decreases the need for virgin materials by 90%
  - Re-processing one tonne of recycled glass saves 30 gallons of the oil used when manufacturing from raw materials



### Why we should Recycle National Recycling Targets





What do we need to achieve to hit recycling targets

- Sedgefield Borough Council currently produces 40,000T of household waste each year (enough waste to fill Durham cathedral twice over)
- Kerbside service currently recycles 5,000T or 12.5%
- Other SBC recycling services collect 4,000T or 10%
- 2007/08 Recycling target = 20% (8000T)
- 2009/10 Recycling target = 40% (16,000T)

We therefore need to:

- Minimise amount of waste produced
- Maximise recycling rates

# Why we should Recycle Avoiding Landfill Tax



- Co. Durham landfills 146,000 tonnes of Household Waste each year
- 2007/08 landfill tax is £24/T (£3,504,000)
- 2008/09 increase to £32/T
- 2009/10 increase to £40/T
- 2010/11 increase to £48 (£7,008,000)

# Why we should Recycle Landfill allowance



- Landfill Allowance Trading Scheme
- Requires reduction of Biodegradable waste being landfilled
- From 146,000 tonnes to 118,000 by 2010
- Penalty of £150 per tonne for exceeding our allowance



# Why we should Recycle Summary



Improved Kerbside Recycling contributes to:

Greencycle:

- Formed in 2005
- Passion for recycling and innovation, (which it believes, differentiates it and from other waste management companies)
- Don't own any landfills
- Currently investing in material processing plants
- Congleton District Council Contract





Greencycle's proposal offers a service that:

- Maximises recycling by increasing the range of materials to be collected i.e. cardboard and paper
- Has a local depot.
- Creates local employment.
- Provides a dedicated "recycling Education Officer" for each contract area
- Provides a £2 per tonne donation to local environmentally aware organisations.





**Service Materials** 

The recyclate to be collected:

- 1. Mixed glass
- 2. Mixed cans and metal including foil
- 3. Mixed paper and card
- 4. Plastic bottles and mixed plastics

#### Paper

Acceptable	Not Acceptable
Newspapers / Magazines Catalogues Brochures / Flyers / Junk mail Telephone directories / Yellow Pages Envelopes Office paper / Wrapping paper Books/manuals	Laminated paper Toilet / kitchen / make up tissues



#### Glass

Acceptable	Not Acceptable
Bottles and jars (all colours) (all glass containing food must be washed out and lids removed)	Window panes Cook ware / pots (ie Pyrex) Reinforced glass Ceramics (ie plates and bowls)

#### Cans

Acceptable	Not Acceptable
Steel food/drinks cans Aluminium food / drinks cans Aluminium foil / food trays Biscuit tins Aerosols (deodorant / hair spray / cleaning / air freshener) (all must be washed out)	Any steel or aluminium can/tin/foil that is contaminated with food waste. Spray paints / chemical sprays



#### **Plastics**

Acceptable	Not acceptable
Bottles (with lids / caps removed) Yogurt pots Margarine tubs Ice cream tubs Shopping carrier bags Plastic film/wrapping Bubble wrap Survival recycling sacks (all plastics containing food must be washed out)	Ready meal food trays (Polystyrene) Hard plastic containers Children's toys

Greencycle believes that by offering to collect a considerably wider range of recyclate, participation will increase across the range as it becomes more obvious what can be recycled.

- The service will be using 4 no. compartmental recycling vehicles each with a driver and three operatives plus a spare vehicle will be provided to cover for breakdowns etc.
- Samller caged vehicles for areas of restricted access and outlying farms
- All vehicles will be purchased new for this contract

- Shredded and sold on the open market.




