Introduction

Noise monitoring equipment has been installed within residential premises for a period of time to assess whether a statutory noise nuisance is evident.

This report is an assessment by officers of the Nuisance Action Team of the data/information collected during the monitoring exercise.

The report contains the complainant's written diary and a review of the recordings of noise made by the complainant. Comments by officers may also be included as may noise levels in decibels.

The report may provide supporting evidence in pursuance of legal proceedings undertaken by EHCP.

The report does not constitute stand-alone evidence that a statutory noise nuisance exists.

Equipment used & set up procedure

Equipment:

- 1) A Norsonic 140 NNR (Noise Nuisance Recorder) was used incorporating a Sound Level Meter, a remote microphone and hand switch.
- 2) Tripod for microphone support.

Set-up Procedure

A calibration tone was recorded on the NNR at the commencement of the monitoring using a sound level calibrator conforming to BS 7189:1989. This provides a record of the equipment being calibrated. In addition an internal calibration tone was set from the sound level meter to provide a reference tone.

The installing officer's voice was recorder on the NNR at the beginning of the monitoring period detailing the date, location and NNR used. This serves to verify the proper operation of the system as well as to provide a noise indicator of conversation speech level. Once the setup of the equipment was complete the box was locked.

The complainant was provided with record sheets and asked to keep a diary of noise disturbance for the monitoring period. They were asked to make representative recordings, making at least one recording for each diary entry.

The NNR equipment was set up to automatically makes a 3 minute second recording each time the hand control is activated.

Post - Installation Analysis

The continuous noise data and audio files accumulated over the monitoring period by the NNR were downloaded onto a computer and the information presented graphically using Nor-Review, a dedicated software package.

The recordings were listened to in sequence and comments made on the principal sounds which were found in the table below.

The history graphs produced by the software were also examined in conjunction with the recordings and diary record sheet(s) and the overall results recorded in the Conclusion of this report. Graphs have been included within the results where necessary.
