Helen,

Following on from our telephone conversation, I would like to formally layout what a tables and chairs licence does and does not allow;

- Consent is for the placement of tables and chairs on an agreed area of the adopted highway, for the use of the clientele of the premises
- The premises is to carry PLI, to the minimum of £5 million, to indemnify the County Council against all liability for any loss of or damage to property or injury to persons any other expenses, loss, damage, costs, actions, suits, proceedings or claims in connection with the placement of tables and chairs upon the adopted highway.
- The licence **does not** allow the placement of anything other than tables and chairs.
- Consent **does not** confer any licence for the sale to or consumption by the clientele of the premises or by any other persons of intoxicating liquor (Permission for this must be sought from the proper sources)

The situation currently with Port of Call is that they have paid for their licence, signed a copy of the terms and condition, but have yet to supply us with a copy of their PLI. I have carried out a Land Registry search and the land outside of their premises is showing as having no known owner, as such DCC would have the final say as to whether an event, such as the one being requested, is allowed due to the fact the area of land is adopted highway.
