The applicant, Mohammed Asif Shariff, hereby gives notice to the Licensing Authority of amendments he makes to his application for a premises licence for the provision of late night refreshment, further to the amendments made by notice dated 23 December 2021.

The further amendments are made following constructive dialogue with Sgt 484 Caroline Dickenson of the Licensed Economy Team of the Safeguarding Neighbourhoods Command of Durham Constabulary in response to Durham Constabulary's representations in relation to Mr Shariff's application.

The application, as originally submitted, includes a proposed condition that last orders shall be taken at least 30 minutes before the terminal hour, so last orders shall be taken no later than 02:30 and 01:00, as the case may be.

The Loft Nightclub at 17 North Road is licensed Monday to Saturday to 02:30, Sunday to 00:30 and to 02:30 on the Sunday of a Bank Holiday weekend.

Other premises licensed exclusively for the provision of late night refreshment are licensed up to Monday to Saturday to 03:00 and 01:00 on Sunday.

The application, as originally submitted, includes a range of proposed conditions to ensure the premises do not become a cause for anti-social behaviour or noise nuisance to local residents, which conditions have not required amendment.
