4 Minutes

The minutes of the meeting held on 28 November 2018 were agreed as a correct record and signed by the Chairman.

6 Application for the Ongoing Suitability of a Hackney Carriage Driver

A second witness was called by the Licensing Team Leader to present evidence and respond to questions from Members, Officers and the Licence Holders representative.

A third witness was called by the Licence Holder's representative to present evidence and respond to questions from Members and Officers.

The Licence Holder's representative was invited to address the Sub-Committee with regards to matters outlined in the report and the Licence Holder responded to questions from Members and Officers.

At the Sub-Committee retired to deliberate the application in private at 12.35 p.m. and at 13.00 p.m. the Chairman delivered the Sub-Committees decision.
