The Licensing Enforcement Officer was in attendance and outlined the Licensing Enforcement report. Members and the Licence Holder were given the opportunity to ask questions of the Officer.

The Licence Holder and her representative were invited to address the Sub-Committee and responded to questions from Members. Information that the Licence Holder had provided in relation to the Deregulation Bill in 2014 was circulated to Members. Members were advised that this particular part of the Bill had been removed from the Bill at the Lords Committee stage and was not the current law.

After Summing up, the Sub-Committee retired to deliberate the application in private at 10.55 a.m. After re-convening at 11.15 a.m., the Chairman delivered the Sub-Committee's decision.

After Summing up, the Sub-Committee retired to deliberate the application in private at 1.00 p.m. After re-convening at 1.25 p.m., the Chairman delivered the Sub-Committee's decision.

**Resolved:** That the Licence Holder's Hackney Carriage and Private Hire Driver's Licence be revoked with immediate effect.
