### **1 Apologies for Absence**

### **3 Minutes**

The minutes of the meeting held on 12 January 2022 were confirmed as a correct record and signed by the Chair.

### **4 Declarations of Interest**

## **6 Consideration of an Application to be Licensed as a Joint Hackney Carriage and Private Hire Driver**
