## **6 Consideration of the Ongoing Suitability of a Hackney Carriage and Private Hire Vehicle Licence Holder**

The Licence Holder was then invited to address the Sub-Committee and responded to questions from Members and Officers.

After all parties were given the opportunity to make a closing statement, the Sub-Committee retired to deliberate the matter in private, at 2.25 pm. After re-convening at 2.30 pm, the Chair delivered the Sub-Committee's decision.

**Resolved:** That the Licence Holder be issued with a written warning for a period of 3 months.
