#### 1 Prayers

Prayers were said by Canon Michael Everitt.

#### 2 Apologies for Absence

## 6 The newly elected Mayor to receive the Seal and make the Declaration of Acceptance of Office of Mayor

Councillor L Mavin received the Seal and read the Declaration of Acceptance of Office as Mayor of Durham which she then signed.

# 7 Mayor's Acceptance Speech

The Mayor welcomed everyone and conveyed that she was honoured and privileged and would do her upmost to perform her duties as Mayor of Durham. She indicated that her chosen charity was St. Cuthbert's Hospice and provided details of the charity, in particular that they only received 35% of the required funding from the NHS and the remainder was through fund raising.

She welcomed representatives from the Hospice who were here today and thanked fellow Trustees and Councillors L Brown and J Blakey for her nomination.

She continued by thanking Councillor D Freeman for his support over the last year and a special thank you to staff at the Town Hall, the Mayor's Bodyguard and the Mayor's Secretary.

She indicated that the Mayor's Rosette for 2023/24 would be Green and Red which were the colours of St. Cuthbert's Hospice and the colours of her primary school.

She expressed her appreciation to friends and family and her husband who had been her rock for the last 35 years.

## 1 Apologies for Absence

An apology for absence was received from Councillor D Hall.

#### 2 Declarations of interest

There were no declarations of interest.

#### 3 Revenue Outturn for the year ending 31 March 2023

Charter Trustees received a report of the Treasurer that provided information on the actual expenditure compared to the budget for the year ended 31 March 2023 (for copy see file of minutes).

The Treasurer reported that the actual net expenditure for 2022/23 was  $\pounds 59,522$ , an underspend of  $\pounds 13,241$  against a budget of  $\pounds 72,763$ . The general reserve balance at 1 April 2022 was  $\pounds 80,358$ . With an underspend of  $\pounds 13,241$  a contribution of  $\pounds 2,539$  had been taken from the reserve, rather than the original budget draw from the reserve of  $\pounds 15,780$ . Consequently, the reserve balance had reduced to  $\pounds 77,819$  as at 31 March 2023. In 2023/24 there was a commitment to draw  $\pounds 15,477$  from the reserve which would result in a reserve balance of  $\pounds 62,342$  as at 31 March 2024.

#### **Resolved:-**

That the outturn position for the year ended 31 March 2023 be noted.

## 4 Annual Return for the year ended 31 March 2023

Charter Trustees considered a report of the Treasurer that sought approval of the Annual Governance Statement and Accounting Statements for the financial year ended 31 March 2023, which were included in the Annual Return (for copy see file of minutes).

#### **Resolved:-**

That the Annual Return (Sections 1 and 2) for the financial year ended 31 March 2023 be approved.

The Mayor agreed that in order to keep members informed, the next items of business could be reported.

## **Report of Jeff Garfoot, Treasurer**

#### **Purpose of the Report**

- 1 The purpose of this report is to provide information on the:
  - a) actual expenditure compared to the profiled budget for the period ending 30 September 2023;
  - b) forecast of expenditure to 31 March 2024 in comparison to the 2023/24 original budget.

#### Background

2 The Charter Trustees for the City of Durham approved the Revenue budget for 2023/24 at its meeting on 25 January 2023.

#### **Comparison of Revenue Outturn with Budget**

- 3 At 30 September 2023 actual net expenditure was £10,730; an underspend of £27,249 (or 71.7%) against a profiled budget of £37,979.
- It is anticipated that actual net expenditure at 31 March 2024 will be lower than the original budget of £75,958 by £6,691 (or 8.8%). The sum required to be drawn from reserves to balance the budget is expected to reduce from £15,477 to £8,786.
- 5 The above forecast of outturn position is mainly due to the projected underspend on the Mayor's Hospitality. If the actual expenditure increases during the remainder of the financial year, it will simply increase the transfer from the General Reserve to be more in line with the agreed budget.

- 6 An analysis of the expenditure over subjective budget headings is set out in Appendix 2.
- 7 Explanations regarding the main variances between actual expenditure and the budget are provided below:

#### **Employees**

8 The forecast expenditure matches the budget set for the Mayor and Deputy Mayor's Allowance.

#### Transport

9 It is anticipated that actual expenditure on transport will be £13,070 at the financial year end which is £643 (or 5.2%) more than the original budget. This is mainly due to a projected overspend in respect of the use of the bus hire.

#### **Supplies and Services**

Based on an estimate of future spending, the supplies and services outturn figure at 31 March 2024 is expected to be £14,556; an underspend of £6,558 (or 31.1%) in comparison to the annual budget. The projected underspend is mainly in respect of the Mayor's Hospitality budget and reflects the fact that only £6,439 has been spent to date.

#### **Forecast of Outturn**

11 The latest forecast of net expenditure to 31 March 2024 is £69,267, an underspend of £6,691 (or 8.8%) against the net expenditure budget of £75,958.

#### **General Reserve**

12 The general reserve balance at 1 April 2023 was £77,818. With a projected underspend of £6,691, the amount required to be drawn from reserves would be £8,786, rather than the original budget figure of £15,477. Consequently, the reserve balance would decrease to £69,032 as at 31 March 2024.

# VAT

13 As at 30 September 2023 the total VAT paid and reclaimed was £373.12.

## Budget Setting 2024/25

- 14 A report will be presented to the meeting on the 6 December 2023 to provide information to enable the Charter Trustees to determine the budget requirement for 2024/25 and the basic level of council tax for the financial years 2024/25 to 2027/28.
- 15 This meeting will also agree the precept for 2024/25 in order to meet the Council's deadline.

#### Recommendation

- 16 It is recommended that the City of Durham Charter Trustees:
  - a) note the outturn position for the period ended 30 September 2023;
  - b) note the forecast of outturn to 31 March 2024;
  - c) note the 2024/25 Budget report will be presented to the meeting on 6 December 2023.
