The Annual Governance Statement needed to be formally approved as part of the consideration of the Annual Governance and Accountability Return 2023/24 (for copy of report, see file of minutes).

# 4 Revenue Outturn for the year ending 31 March 2024

Charter Trustees received a report of the Treasurer that provided information on the actual expenditure compared to the budget for the year ended 31 March 2024 (for copy of report, see file of minutes).

The actual net expenditure for 2023/24 was £70,412, an underspend of £5,546 against a budget of £75,958. The original budget agreed a contribution

from reserves of £15,477. Based upon the final underspend there would be a transfer from reserves of £9,931. In 2024/25 there was a commitment to draw £19,085 from the reserve that would result in a reserve balance of £48,802 as at 31 March 2025.

The Treasurer indicated that the budgeted use of reserves was not an infinite budget solution, and they would need to consider how they reduce their reliance on reserves. Trustees were also asked to note that there would be a reduction in the Local Council Tax Reduction Scheme by 50% phased over the next three years. He stated that Trustees would need to consider in due course how they budgeted for the change in income source.

**Resolved:** That the outturn position for the year ended 31 March 2024 be noted.

## **Report of Rob Davisworth, Treasurer**

## **Purpose of the Report**

The purpose of this report is to provide information on the forecast of expenditure to 31 March 2025 in comparison to the 2024/25 original budget.

## Background

The Charter Trustees for the City of Durham approved the Revenue budget for 2024/25 at its meeting on 6 December 2023.

# **Comparison of Revenue Outturn with Budget**

- The projected net expenditure of £68,285 at 31 March 2025 will be lower than the original budget of £78,425 by £10,140 (or 12.9%). The sum required to be drawn from reserves to balance the budget is expected to reduce from £19,085 to £8,947.
- The above forecast of outturn position is mainly due to the projected underspend on the Mayor's hospitality budget, an underspend on the administration budget and additional bank interest, offset slightly by a projected overspend in relation to civic transport.
- 5 An analysis over subjective budget headings is set out in Appendix 2.
- 6 Explanations regarding the main variances between the budget and the projected outturn are provided below:

#### **Transport**

It is anticipated that expenditure on transport will be £16,250 at the financial year end which is £1,428 (10%) more than the annual budget. This is mainly due to a projected overspend in respect of the use of the civic car hire.

## **Supplies and Services**

The supplies and services outturn figure at 31 March 2025 is projected to be £11,904; an underspend of £4,235 (26%) in comparison to the annual budget. The projected underspend is mainly in respect of the Mayor's hospitality budget.

#### Income

Income is projected to be £4,152 against a budget of £500; an overachievement of income of £3,652. This is due to the civic dinner income being unbudgeted. A budget line for this income stream will be included within the 2025/26 budget.

#### **Forecast of Outturn**

The latest forecast of net expenditure to 31 March 2025 is £68,285, an underspend of £10,140 (or 13%) against the net expenditure budget of £78,425.

#### **General Reserve**

The general reserve balance at 1 April 2024 was £67,887. With a projected underspend of £10,140, the amount required to be drawn from reserves would be £8,947, rather than the original budget figure of £19,085. Consequently, the reserve balance would decrease to £58,941 as at 31 March 2025.

# **Budget Setting 2025/26**

- A report will be presented to the meeting on the 11 December 2024 to provide information to enable the Charter Trustees to determine the budget requirement for 2025/26 and the basic level of council tax for the financial years 2025/26 to 2028/29.
- This meeting will also agree the precept for 2025/26 in order to meet the Council's deadline.
