2 Minutes of the meeting held on 15 December 2010

Consideration was given to the report of the Corporate Director, Neighbourhood Services which requested Members to determine any action necessary in relation to the Licence Holder's hackney carriage and private hire driver licences.

Representations were heard from Durham Constabulary and the Licence Holder's solicitor responded to the issues raised.

The Licence Holder's solicitor then presented his case, handing up a written reference from the Licence Holder's employer, together with a medical report in relation to the matters the Sub-Committee was being asked to consider. The Licence Holder and his solicitor responded to questions from the Police representative and Members of the Sub-Committee.

Members of the Sub-Committee retired to deliberate in private at 11.10am.

After reconvening at 11.25am, the Chair delivered the Sub-Committee's decision.

That the suspension be lifted and the hackney carriage and private hire driver's licences be restored.
