## **Purpose of the Report**

The purpose of this report is to introduce the presentation by the Housing Renewal and Improvement Manager, Regeneration and Economic Development focusing on bringing Empty Homes back into use in County Durham.

## **Background**

- Members will recall that at the meeting of the Economy and Enterprise Overview and Scrutiny Committee held on the 4 April 2011, a refresh of the Work Programme for 2011-2013 was considered within the context of the 'Altogether Wealthier' priority theme of the Council Plan 2011-2013. As a result of this refresh, Empty Homes was identified for inclusion within the Committee's current Work Programme for 2011-2013.
- In addition quarterly Performance Reports considered by the Economy and Enterprise Overview and Scrutiny Committee have identified as a key performance improvement issue the number of empty homes brought back into use as a result of Local Authority intervention.
- As Empty Homes is a cross cutting issue which cuts across the 'Altogether Wealthier' and the 'Altogether Safer' themes of the Council Plan, Members of the Safer and Stronger Overview and Scrutiny Committee have been invited to attend this initial overview presentation.
