The Licence Holder addressed the Sub-Committee and responded to questions from Members of the Sub-Committee, he also circulated leaflets regarding his business.

The Sub-Committee retired to deliberate the application in private at 12.10 pm. After reconvening at 12.15 pm, the Chair delivered the Sub-Committee's decision.

That the Licence Holder be granted an exemption for the requested vehicle to be exempt from displaying the Council vehicle plate and door crests for executive hire and proms.
