**Purpose of the Report**

An amendment is required to the Durham City Off Street Parking Places Traffic Regulation Order to manage and control parking within Providence Row, Durham.

**Executive summary**

Providence Row – To introduce Market Trader Permit Only parking (Saturday 6am-10am) restrictions. Which will allow for market traders to park during market day on Saturday after The Sands car park closes to the public.

An exemption order is required to the 'Durham City Off Street Parking Places Order 2008' and 'Notice of Variation of Parking Charges - Durham City Off Street Parking Places Order 2009 Variation No 1 Order 2012'

To allow market traders with permits to park in this location with permit holders and pay & display being suspended during this duration.

The area reverts to permit holders and pay & display outside of the market trader permit only parking timings.

## **Background**

### Providence Row

Providence Row is a busy road leading from Claypath towards residential properties, Durham Sixth form, Freemans Quay and The Sands car park. The proposed area has the current restrictions of 'Permit Holders Only (F) and Pay and Display parking (Mon-Sat 8am-6pm)'.

There has been request from a market trader due to the Durham County Council HQ application to introduce 10 no. 'Market Trader Permit Holders Only Parking Saturday 6am-10am' bays in the south western section of this car park. During this time only Market permit holders will be allowed to park in this section, however they will still be required to pay and display. Outside of these times the restrictions will return to 'Permit Holders Only (F) and Pay & Display parking'.

An exemption order is required to the 'Durham City Off Street Parking Places Order 2008' and 'Notice of Variation of Parking Charges - Durham City Off Street Parking Places Order 2009 Variation No 1 Order 2012'
