### **Purpose of the Report**

To consider a request for temporary traffic regulation by Order on 28 October 2019 for the purpose of carriageway resurfacing, lining and footway infrastructure improvement and construction works over 5 weeks.

It is recommended that the Council exercises its powers under the Road Traffic Regulation Act 1984 to effect a Temporary Traffic Regulation Order to facilitate the proposed works.

### **Background**

Works are proposed to undertake carriageway resurfacing, lining and footway infrastructure improvement and construction works within the confines of the highway.

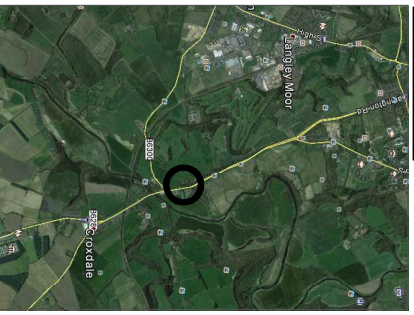
