I am writing this letter in support of the licence application for the above premises proposed to be "CAPS OFF BREWERY".

CAPS OFF Bottleshop has already proven itself to be an asset to the local area, supporting many independent businesses from across the county, including producers of expensive and premium artisan drink products, as well as independent street food traders championing local produce.

They are a diligent operator, working with the local Town Council and the County Council on many occasions, and encourage quiet enjoyment of expensive drinks in a community-based atmosphere, and as such have a done a lot to raise the profile of the local area.

Durham County Council recommends operators of premises licences charge a minimum of £0.50 per unit of alcohol. CAPS OFF currently operate at the premium end of the market and vastly exceed this price point. A quick glance through their social media pages reveals examples such as £5.20 a pint for 5.4% and £3.25 a half for a 7.0% beer. This equals £1.69 and £1.63 per unit respectively – more than THREE TIMES the minimum recommended price point.

If you compare these prices to the many premises around Bishop Auckland, it is immediately clear that CAPS OFF are aimed at the premium end of the market, and as such they do not encourage binge drinking, and don't have silly drinks promotions from macro-producers plastered all over their walls.

The insinuation that such a premises and operator would be a danger to under-age drinkers and encourage youth drinking is farcical at best, and malicious at worst.

It wasn't so long ago that licenced premises in the local area were packed with under-age drinkers, and the market place even provided mobile urinals for those using the seedy drinking pits that operated as late night clubs on a Friday and Saturday night.

Having seen the care and attention to CAPS OFF Bottleshop, I am in no doubt that the proposed new establishment will be equally as classy and community-based, to further enrich the local area.
