Purpose of the Report

To consider a request for temporary traffic regulation by Order on Saturday 21 March 2020 for the purpose of new manhole works completion.

Recommendation

It is recommended that the Council exercises its powers under the Road Traffic Regulation Act 1984 to effect a Temporary Traffic Regulation Order to facilitate the proposed works

Background

Works are proposed by DCC Drainage Team to undertake new manhole works within the confines of the highway. Works were anticipated to take 5 days under a Notice but will extend into a sixth day.

Other traffic management arrangements have been considered and the most appropriate method is to complete the works under a road closure

The recommendation is approved and that following, consultations with the Chief of Police, arrangements be made to progress the advertising of Public Notices and sealing of an Order.

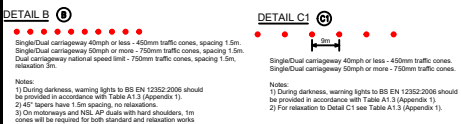

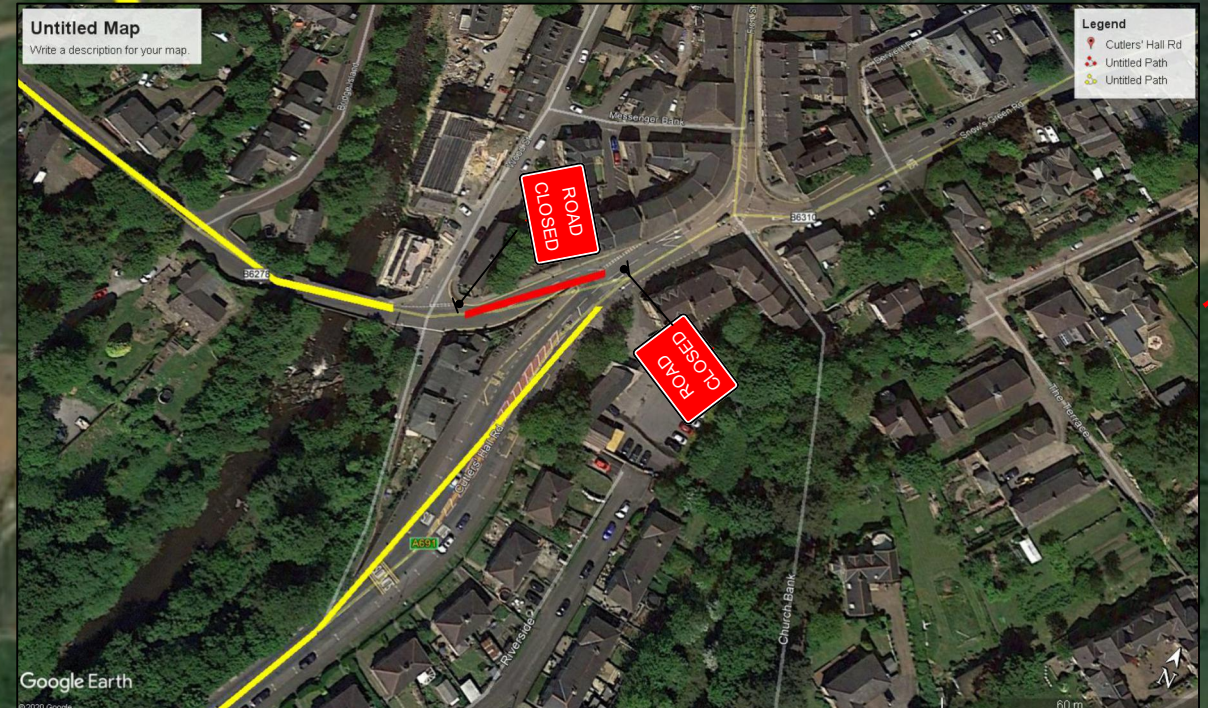
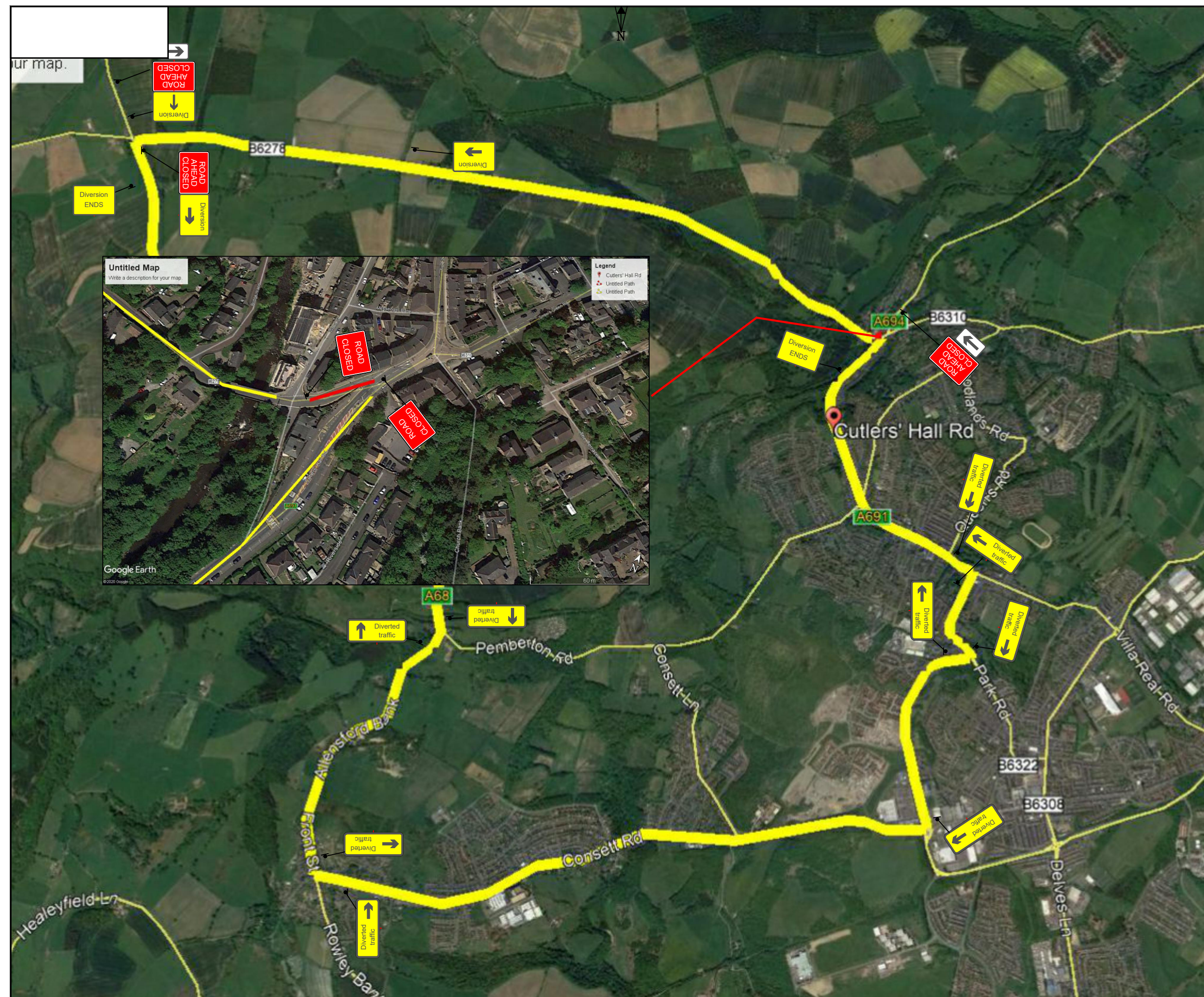
