

## **DURHAM COUNTY COUNCIL**

At a Meeting of **Cabinet** held in the **Council Chamber, County Hall, Durham on Wednesday 18 March 2020 at 10.00 am**

Prior to the commencement of the meeting the Leader of the Council advised of the unprecedented and challenging times ahead as a result of the outbreak of Covid-19. He emphasised that the council would do all it could in this emergency situation to protect the most vulnerable, and that it would need to make changes to the services it provides so that it could target its resources in the most effective way, and in doing so its operation may look very different. The council would ensure that it kept its communications with its residents and businesses of high importance. He went on to advise that in the circumstances there would be no formal committee meetings of the council being held or convened until the end of March and that this position would be kept under review.

#### **4 Local List of Historic Parks, Gardens and Designed Landscapes [Key Decision: REAL/01/2020]**

The Cabinet considered a report of the Interim Corporate Director of Regeneration and Local Services which sought approval for the adoption of a Local List of Historic Parks, Gardens and Designed Landscapes for County Durham, and, sought approval of a review process to update and add to the Local List on a 5 year cycle (for copy see file of minutes).

#### **5 Options for the future of the two schools that constitute the Durham Federation**

The Cabinet considered a joint report of the Corporate Director of Children and Young People's Services and the Corporate Director of Resources which outlined the educational and financial sustainability issues, and, presented a set of options for the future of Durham Community Business College and Fyndoune Community College, which jointly comprise the Durham Federation. In response to the questions and comments made by Councillor H Liddle, one of the local members, of which included the allocation of places at an alternative school, school transport, safe walking to school, community facilities, and inclusion of community of Sacriston in consultation, Councillor Napier in noting these advised that these would be picked up in the consultation and a written response would be made to the member.

Councillor Henig advised that the questions submitted by the parish council had been made after the deadline had passed, and that he would ask that a written response be made to the parish council.
