### **Purpose of the Report**

To consider a request for temporary traffic regulation by Order on 15 January 2021 for the purpose of facilitating development works at Framwellgate Waterside, Durham.

### **Recommendation**

It is recommended that the Council exercises its powers under the Road Traffic Regulation Act 1984 to effect a Temporary Traffic Regulation Order to facilitate the proposed works

### **Background**

Works are proposed by Tolent Construction to undertake development works adjacent to the confines of the highway requiring HGV movements into and out of the site.

### **Options**

Other traffic management arrangements have been considered and the most appropriate method is to suspend parking and re-designate other areas during the anticipated 12 month period from January 2021.

### **Recommendation**

The recommendation is approved and that following, consultations with the Chief of Police, arrangements be made to progress the advertising of Public Notices and sealing of an Order.

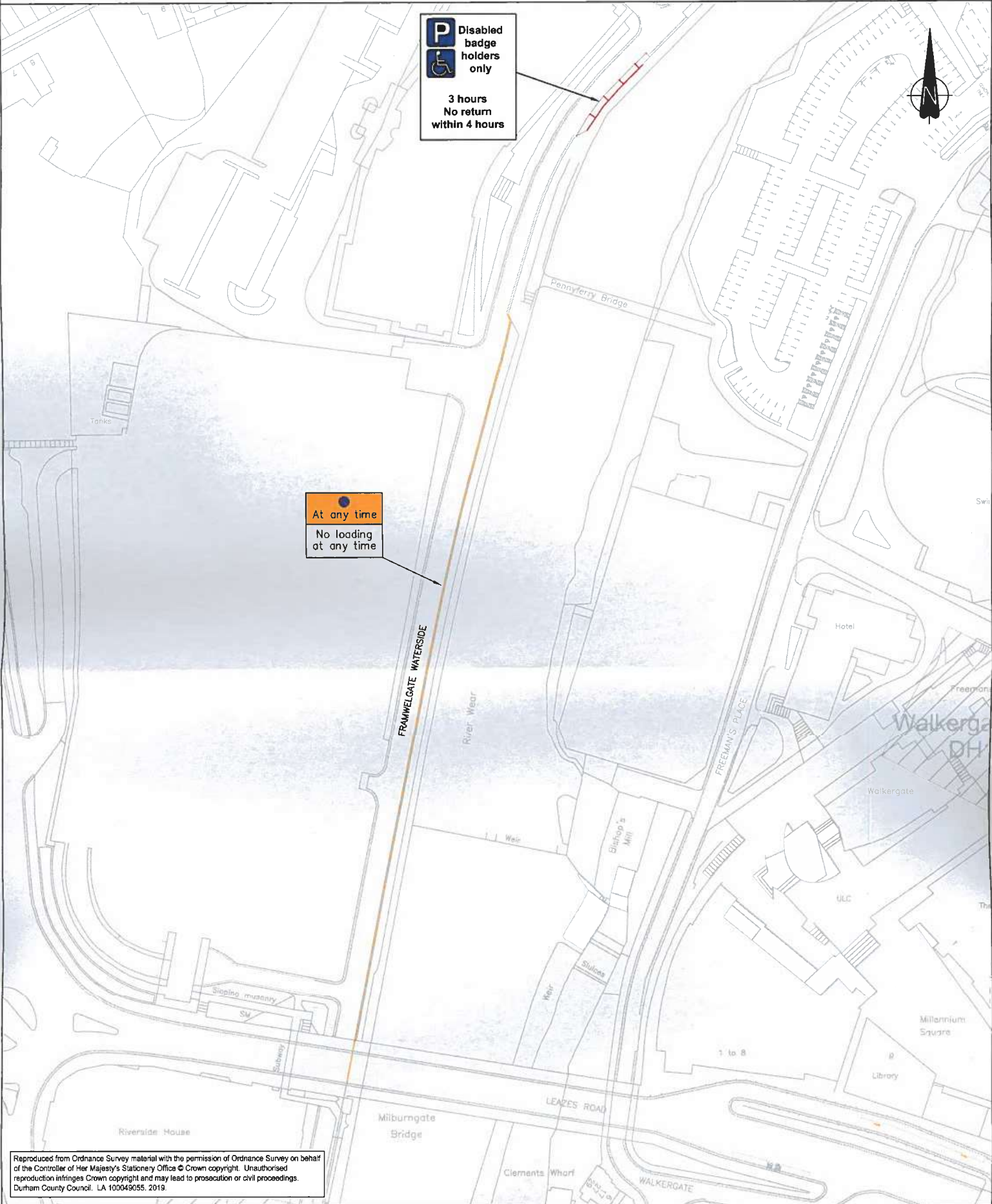
