I am the above named Police Constable employed by Durham Constabulary as a Neighbourhood Officer stationed at Crook Police Station.

On Sunday 01st November 2020 I was on duty in full uniform in company with PC 2938 Laycock when we attended Best Kebab, 4 South Street, Crook, DL158NE at around 20:39hours to conduct a Licensing Check at the premises. On arrival to the premises I informed staff present that I was conducting a licensing check, staff then called a male to come talk to me, I asked this male whether he was the manager tonight to which he informed me yes and provided his name as M M. I asked M whether he could show me whether his CCTV is currently in working order and records for 28 days. M attempted to get the upstairs screen to switch on however due to technical difficulties this could not be done, M was able to show me on his phone that the CCTV downstairs was linked to the hard drive upstairs however due to the screen not working he was unable to navigate to show me whether the CCTV play back and record were working. There was good practice in relation to Covid regulations.

On 19th November 2020 at around 20:24hours I returned to the above premises to conduct a further Licencing check and delivery of review papers in full uniform in company with PC 9007 McCabe. I handed the papers to M M who was also managing the premises on this occasion also. M confirmed he was already aware of the review and so was the owner Ismail KADEH who had received it over email. M ensured that the papers would be handed over to KADEH. M signed the PNB of PC 9007 McCABE to this effect.

I request to see the staff training records and was shown the records for C A C K and I B. There was no staff training record for M or KADEH as M stated his was with his boss as he trains KADEH and KADEH trains him so they were not shown to me. I then requested to see the incident logs to which M could not locate, he stated this was because he had tidied everything up due to a health and hygiene inspection.

I ask M whether the CCTV was still the same as my last visit to which he responded 'yes'. M stated that this was because KADEH wasn't very well at the minute so he was trying to leave him alone.

I obtained the details of all staff present at the time of my visit.
