To consider a request for temporary traffic regulation by Order on Monday 16 October 2023 for the purpose of enabling Station Approach to Tenter Terrace footbridge approach and deck resurfacing works in Durham.

Background

Works are proposed by DCC to undertake stepped approach and deck resurfacing works within the confines of the highway.

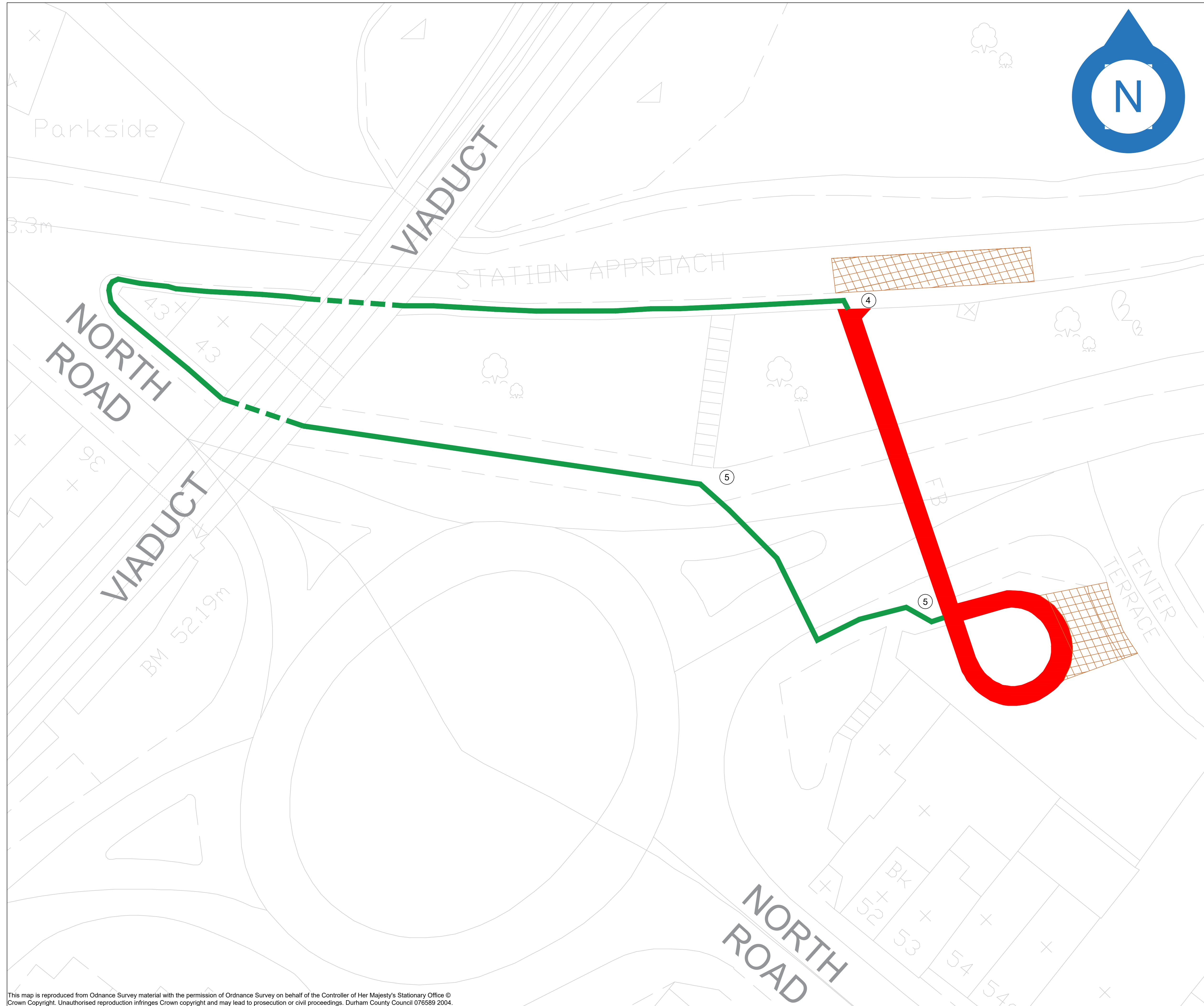
