#### **1** Purpose of the Report

- 1.1 To advise Members of objections received to the consultation concerning proposed changes to the Traffic Regulation Order (TRO) for Bowburn, Shincliffe & High Shincliffe.
- 1.2 To request that members consider the objections made during the informal and formal consultation period.
- 1.3 In accordance with the Council's Constitution, Members are asked to decide, in principle only, whether the TRO should be made, which will then guide the Corporate Director of Regeneration, Economy and Growth in the exercise of delegated decision making. The final decision is therefore one for the Corporate Director, under delegated powers.

#### 2 Executive Summary

2.1 The County Council are committed to regularly reviewing Traffic Regulation Orders to ensure that the restrictions held within them are relevant and appropriate.

- 2.2 Representations have been received requesting a review of existing, and provision of additional, restrictions in Bowburn & Shincliffe.
- 2.3 Having considered these requests, Officers have determined that the changes listed below would be of benefit in terms of improving road safety and reducing congestion. It is therefore proposed to make an amendment to the Bowburn, Shincliffe & High Shincliffe (Parking and Waiting Restrictions) Traffic Regulation Order 2023 to allow the identified additional restrictions to be introduced.
- 2.4 Both local members covering this area fully support the proposals. Durham Constabulary are in full support.

3.1 Committee is recommended to:

Endorse the proposal, in principle, to introduce the Bowburn, Shincliffe & High Shincliffe Parking and Waiting Restrictions, Traffic Regulation Amendment Order 2023, with the final decision to be made by the Corporate Director under delegated powers.

## 4 Proposal, Objections & Responses

- 4.1 The proposed locations for the TRO that received objections during the consultation stages are detailed below.
- **4.2 Durham Road** (to extend existing no waiting and no loading/unloading at any time restrictions)
- 4.3 Proposal Background

The A177, Durham Road is the major access road through Bowburn. The route is heavily trafficked by commuters travelling to and from Durham as well as the nearby Industrial Estates.

To the southeast of Durham Road there are a number of terraced residential properties which rely on access via minor side road

junctions. There are currently bollards and 'no waiting and no loading/unloading' restrictions in strategic locations within this area to prevent obstructive parking.

Residents have now raised concerns, via the elected member, regarding HGV's parking/loading from Durham Road to businesses in the area. Parking/loading from these areas leaves insufficient space within the carriageway for vehicles to pass safely and restricts visibility for all road users.

It is therefore proposed existing 'no waiting and no loading/unloading at any time' restrictions be extended on the A177, Durham Road to prevent obstructive parking and improve traffic flow.

#### 4.7 Objections:

A total of 2 people have objected to this proposal at the 'informal consultation' stage, the reasons for these objections have been summarised below:

- "This action is unnecessary as this [obstructive parking] very rarely happens."
- "It will further congest side roads stopping existing business/residential access."

- 4.8 DCC Response:
  - A traffic island/refuge was previously introduced at this location as a formal crossing point for pedestrian access to and from the Co-Op on the north-eastern side of Durham Road. As a result, the lanes within the available carriageway were narrowed to maintain the flow of single lane traffic in either direction.
  - Delivery vehicles associated with the Co-Op had begun to load/unload from the northern side of Durham Road immediately adjacent to the pedestrian refuge which restricted visibility for all road users approaching the crossing point and restricted traffic flow around the island which, on occasion, forces vehicles into the opposing lane posing concern to road safety.
  - Whilst bollards were introduced on the north-eastern side of the crossing to prevent vehicles from stopping in this location, the footway on the south-western side is considerably narrower and therefore unable to accommodate bollards which has led delivery vehicles to load/unload from this location instead.
  - The introduction of formal 'no waiting and no loading/unloading at any time' restrictions will improve road safety by ensuring that traffic flow is unobstructed and visibility is maintained for all road users approaching the formal crossing point.

#### 5 Conclusion

5.1 Having considered the evidence of obstructive and inconsiderate parking and the objections to the proposals, Officers remain of the view that it is necessary to introduce the proposals in order to address the identified highway safety issues. Accordingly, it is recommended that Members agree in principle to endorse the proposal to proceed with the implementation of the Bowburn, Shincliffe & High Shincliffe (Parking & Waiting Restrictions) Traffic Regulation Amendment Order 2023 with the final decision to be made by the Corporate Director under delegated powers.


