Overview



The MSIF Workforce funding announced in July has provided the Council with funding that can be used to support ASC provider capacity and for ASC waiting lists. Key market sectors and Council operational teams will benefit from the grant funding which will support hospital discharges in terms of assessment and review capacity by DCC staff and also ASC capacity for care packages through provider fee uplift or workforce support funding to aid recruitment and retention. Provider capacity and activity is monitored on an ongoing basis and proactive commissioning work funded through the BCF HD monies has been undertaken to

2. Please outline assumptions used to arrive at refreshed projections (including to optimise length of stay in intermediate care and to reduce overprescription of care). Please also set out your rationale for trends in demand for the next 6 months (e.g how have you accounted for demand over winter?)

Demand:

Over the winter period we expect to see a rise in demand for services (with a peak in activity in December - February), with increased respiratory infections, covid etc. However, effective commissioning and use of both IC+ Beds with appropriate levels of therapy support will enable optimal lengths of stay in that provision with reduced need for ongoing care. Furthermore, the local reablement service will continue to be a key service, supporting those returning directly home to have either reduced or no ongoing care needs; this service performs well in terms of outcomes and we will support the provider to expand capacity further. We Capacity:

Additional capacity has been created for winter in specific services through our commissioning work: additional block IC+ Beds and extensions of the short term dom care service ('STAS')

We have also commissioned on a block basis care home beds for placements that are not eligible for IC+ Beds to support both hospital discharge and admission avoidance.

The services we have commissioned to support people with mental health or housing needs is well established ready for winter and proving an important service for some of the more complex discharges

3. What impact have your planned interventions to improve capacity and demand management for 2023-24 had on your refreshed figures? Has this impact been accounted for in your refreshed plan?

Although we expect an increase in demand for services, as we have both commissioned additional capacity in terms of block beds / care at home hours and also supported wider ASC market sectors with capacity generally we expect the increased demand to be managed for the remainder of this financial year.

4. Do you have any capacity concerns or specific support needs to raise for the winter ahead?

Due to the current position in terms of local care home occupancy, the local domiciliary care market (with no waiting list) and the additional capacity over winter created through commissioning work funded through BCF HD monies and MSIF Workforce Fund, there are no identified concerns for ASC provision for winter. However, we have identified additional therapy resource is needed to support the additional block IC+ beds commissioned for winter and are presently making arrangements for this with local NHS Trust and ICB.

5. Please outline any issues you encountered with data quality (including unavailable, missing, unreliable data).

In terms of social support (VCS), we have only reflected the data from our Home from Hospital Service as that is one of our dedicated IC+ provisions. However, it is likely that significant numbers of people may access our wider commissioned services funded by the BCF. Due to the challenges presented by such wide ranging data collection in restrictive timescales, this is not fully reflected in this dataset.

The NHS Trust data regarding pathways does not align with actual demand as tracked by the LA, it appears that most patients are recorded as needing a long term care home placement (Pathway 3) but many will 6.
