Purpose of the Report

To consider a request for temporary traffic regulation by Order on 26th June 2024 for the purpose of preventing obstruction of the highway during the Durham University Summer Congregation adjacent to Owengate, Durham.

Recommendation

It is recommended that the Council exercises its powers under the Town Police Clauses Act 18474 to effect a Temporary Traffic Regulation Order to facilitate the proposed 8-day event (no closures on the weekend)

Background

A Summer Congregation event is proposed by Durham University which will throng the road adjacent to it.

Options

Other traffic management arrangements have been considered and the most appropriate method is for temporary road closure between 7:00am and 7.00 pm on Wednesday 26th June 2024 to Friday 28th June 2024 and then Monday 1st July to Wednesday 3rd July 2024.

Recommendation

The recommendation is approved and that following, consultations with the Chief of Police, arrangements be made to progress the sealing of an Order.

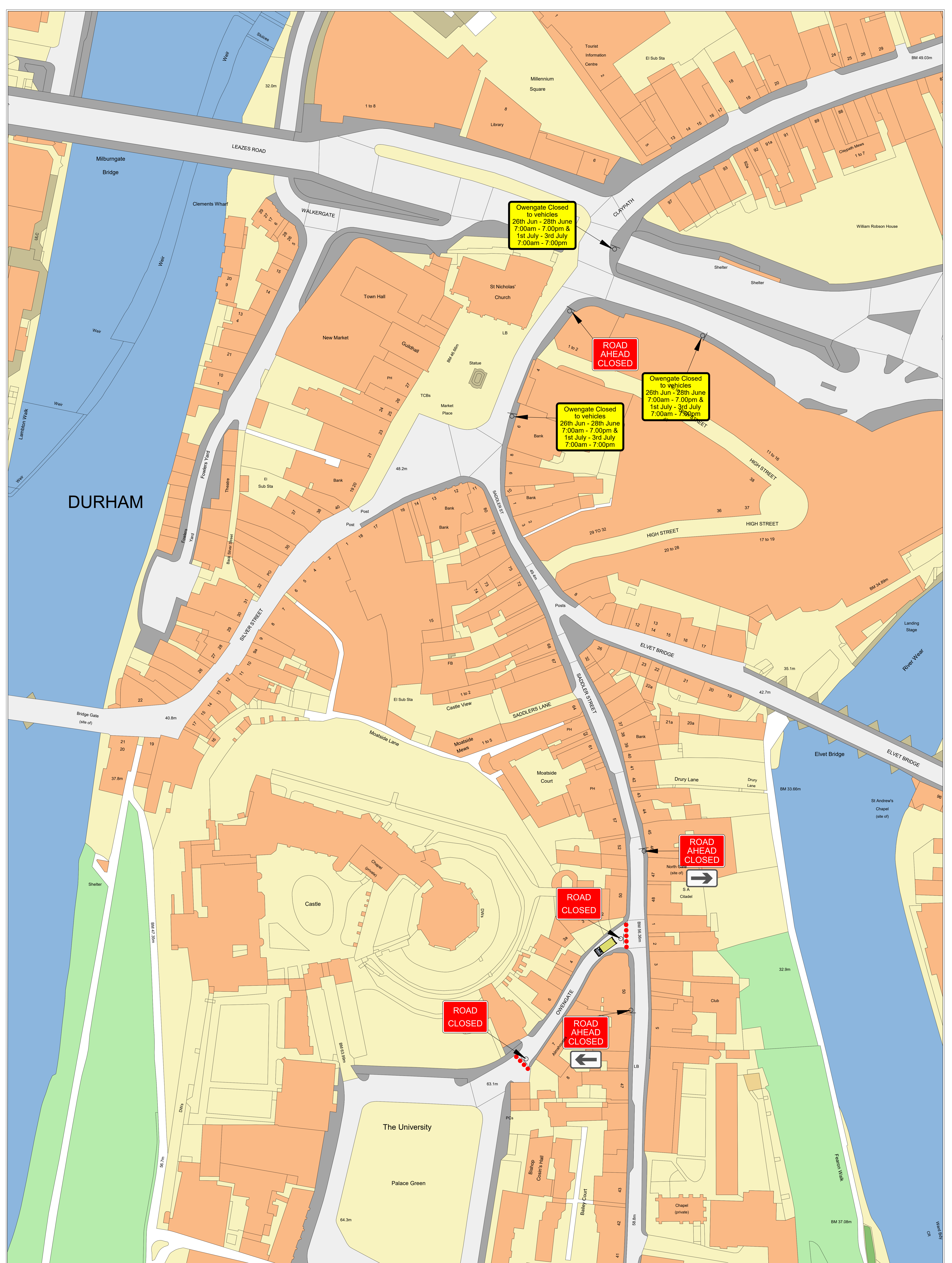
