Grant Funding Agreement -TCF Durham City Centre Active Mode Connectivity - Tranche 2

## **Purpose of the Report**

To approve the formal sealing of grant funding agreement from the North East Combined Authority (NECA) relating to Durham City Centre Active Mode Connectivity. The funding is Transforming Cities Funding Tranche 2. The grant is for design and construction.

## **Executive summary**

The Department for Transport (DfT) awarded funding to NECA from the second tranche of Transforming Cities Funding, of which £2,500,000 has been allocated towards design and construction work for active mode improvements in Durham City Centre.

#### Recommendation

3 The recommendation is to note and authorise for sealing.

### **Background**

- The Transforming Cities Fund (TCF) is a £2.45 billion capital grant transport fund aimed at driving up productivity through investments in public and sustainable transport infrastructure in some of England's largest city regions.
- The fund that was announced in the 2017 Autumn Budget has two key objectives:
  - (a) improve access to good jobs within English cities; and
  - (b) encourage an increase in journeys made by low-carbon and sustainable modes of transport.
- In November 2019, the North East region submitted a Strategic Outline Business Case (SOBC) as a bid for Tranche 2 funding, of which it was successfully allocated £198.5 million. Within the bid, various schemes were located within County Durham which to date have been progressed including:
  - (a) walking and cycling improvements elsewhere within Durham City;
  - (b) expansion of Sniperley Park and Ride site; and
  - (c) improvements to Durham Bus Station.
- In 2023, the North East region invited local authorities to submit proposals for unallocated TCF funding for schemes that could be constructed within the timescales of TCF spending requirements by March 2024. Durham County Council's submission of the Durham City Centre Active Mode Connectivity was successful.
- The package is made up of a number of sub schemes at various locations in the city centre:
  - (a) Stockton Road/New Inn/Quarryheads lane;
  - (b) Whinney Hill;
  - (c) Claypath;
  - (d) Walkergate;
  - (e) Framwellgate Reach;
  - (f) Framwellgate Waterside; and
  - (g) Baileys.

- The TCF funding allocated is £2,500,000 for design and construction work. This is to be supported by existing £1.219 million of highways maintenance funding and £0.494 million of S106 funding, with the latter allocated for sustainable transport improvements in the city centre.
- 10 Construction of these schemes are expected to be undertaken during the 2024/25 financial year.
