# **Purpose of the Report**

To consider a request for temporary traffic regulation by Order on Thursday 23 May 2024 for the purpose of safeguarding the public from erroneous parking in times of seasonal events in Barnard Castle area.

#### Recommendation

It is recommended that the Council exercises its powers under the Road Traffic Regulation Act 1984 to effect a Temporary Traffic Regulation Order to safeguards the public by applying a no waiting restriction on Bridgegate, Barnard Castle.

# Background

To prevent obstruction due to erroneous parking during seasonal events, temporary parking restrictions are scheduled to be implemented on safety grounds within the confines of the highway.

# Options

Other traffic management arrangements have been considered and the most appropriate method is for no waiting at any time restrictions primarily between 23/05/24 to 20/06/24.

The recommendation is approved and that following, consultations with the Chief of Police, arrangements be made to progress the advertising of Public Notices and sealing of an Order.
