## **Purpose of the Report**

To present the Durham Police and Crime Panel Annual report 2023/24 and consider development of the Panel's Work Programme for 2024/25.

# **Executive summary**

The Panel's Annual report provides details of activity undertaken by the Panel in 2023/24 and development of a work programme for 2024/25 in accordance with the Panel's arrangements and requirements within the Police Reform and Social Responsibility Act 2011.

  - (b) Agree the Panel's work programme as attached in appendix 3 for 2024/2025 and the flexibility it offers to respond to emerging issues.

## **Background**

- The Durham Police and Crime Panel annual report presents the Panel's activity during 2023/24. The report, attached in Appendix 2 provides detail on the role and responsibilities of the Police and Crime Commissioner (PCC), the Police and Crime Panel (PCP), the Panel's membership, activity through Panel meetings, Panel development, complaints, engagement with public and the Office of the PCC (OPCC) and Panel support. It is to note that the annual report is to be submitted to the Home Office as an element of the Panel's grant agreement by the 30 June 2024.
- In summary, 2023/24 has been a busy year for the Panel in which we held:
  - five scheduled meetings
  - two special meetings
  - two confirmation hearings for the new Chief Constable of Durham Police and the Chief Finance Officer
  - induction and refresher training
  - briefing sessions for members in advance of the confirmation hearings
  - a briefing session in advance of considering the PCC's precept
  - an informal session to discuss policing in Newton Aycliffe.
- The Panel has continued to deliver its work programme and duties within the Police, Reform and Social Responsibility Act 2011. This has included:
  - receiving the PCC's draft annual report 2022/23
  - considering, approving and responding to the PCC's proposed precept
  - scrutinising the PCC and the Chief Constable of Durham Police on Durham's Constabulary's PEEL Inspections findings
  - receiving a report on missing people and protecting the vulnerable
  - considering an update on force progression on the delivery of recommendations by the Independent Inquiry into Child Sexual Abuse

## Work Programme 2023/24

The Panel's rules of procedure state that the PCP will be responsible for setting its own work programme taking into account the priorities defined by the PCC within the context of the Police and Crime Plan and annual report. The work programme must also include the functions described in the terms of reference for the panel.

- The work programme will enable the PCP to plan and focus on how it will effectively provide challenge to the PCC and deliver its responsibilities within the context of the terms of reference and rules of procedure namely:
  - (a) Review and comment on the draft Police and Crime Plan and precept
  - (b) Reviewing the PCC's annual report
  - (c) Holding confirmation hearings following a proposed appointment by the PCC to the posts of Chief Constable, Deputy PCC, Chief Executive Officer and Chief Finance Officer within the Commissioner's Office.
- In addition, the Panel's meetings receive a quarterly performance report which includes:
  - (a) Key performance indicators
  - (b) Safer communities force staffing levels, public contact methods, neighbourhood crime, anti-social behaviour
  - (c) Safer people violent crime
  - (d) Non-crime demand missing from home and mental health
  - (e) Safer roads casualties, safety campaigns
  - (f) Funded services for victims community peer mentors, victim care and advice service, Ministry of Justice funding, safer streets, CCTV and security control centre
  - (g) HMICFRS reports
  - (h) Media and engagement
  - (i) PCC decision records
- The Panel can also establish 'sub committees and task groups' to undertake specific task based work on issues it deems necessary in line with its remit.
- 11 Appendix 3 outlines a work programme for 2024/25 which is flexible to accommodate additional items throughout the year.

# Chair's Foreword

Welcome to the Durham Police and Crime Panel annual report for 2023/24 which provides detail on our activity throughout the past year.

Having served as a substitute member of the Police and Crime Panel, I was delighted and honoured to be elected as the Panel's Chair together with Cllr Gerald Lee as Vice Chair at its annual general meeting in June 2023.

In summary, 2023/24 has been a busy year for the panel in which we held five scheduled meetings, two special meetings, two confirmation hearings and several briefing sessions in advance of confirmation hearings and consideration of the PCC's precept.

Within this period, the panel received the PCC's draft annual report 2022/23 in September 2023, confirmed the appointment of Rachel Bacon as the new Chief Constable of Durham Constabulary in September 2023 and the appointment of the OPCC's Chief Finance Officer in January 2024.

The Panel agreed the PCC's precept in February 2024 and responded accordingly to the OPCC.

The Panel has continued to deliver its work programme and duties within the Police, Reform and Social Responsibility Act 2011.

I would like to thank the office of the Durham PCC for their continued support and to all Panel and substitute members for their valued and dedicated commitment to the work of the Durham Police and Crime Panel. I would also like to thank all the support staff for their work and the Monitoring Officer for her advice and assistance to me in my role as chair of the Panel.

# **Background**

The Police Reform and Social Responsibility Act 2011 introduced arrangements for elected Police and Crime Commissioners who are to be the voice of the people and have responsibility for holding their chief constable to account for policing in their force area. The Act also required the establishment of a Police and Crime Panels who are required to scrutinise and support the work of the Police and Crime Commissioner.

Elections for Police and Crime Commissioners take place every four years. The first election in November 2012 elected Mr Ron Hogg as the Durham Police and Crime Commissioner and following re-election in May 2016, Mr Hogg included victims within his title to be known as the Durham Police, Crime and Victims' Commissioner (PCVC).

Following his death, Steve White, Chief Executive, Office of the Durham PCVC, was appointed acting PCVC in September 2019, by the Police and Crime Panel.

Elections for Police and Crime Commissioners were scheduled to take place in May 2020 however due to Covid 19 elections were postponed.

In May 2021 Joy Allen was elected as the Durham PCC.

Following elections in May 2024, Joy Allen was re-elected to the position of PCC in May 2024.

# **Police and Crime Commissioner**

The role of the PCC is to be the voice of the people and hold the police to account. They are responsible for the totality of policing.



The PCC is elected by the public to hold the Chief

Constable and the force to account, making the police answerable to the communities they serve. The PCC is to ensure community needs are met as effectively as possible and are improving local relationships through building confidence and restoring trust. The PCC works in partnership across a range of agencies at local and national level to ensure there is a unified approach to preventing and reducing crime.

The PCC has the mandate for ensuring the effectiveness and efficiency of policing services across County Durham and Darlington. As well as holding the Chief Constable to account on behalf of local people, the role also involves:

- represent and engage with all those who live and work in the force area, including the vulnerable and victims
- set the police and crime objectives for their area through a police and crime plan
- set the force budget and determine the precept
- appoint the Chief Constable, hold them to account for running the force, and if necessary, dismiss them
- contribute to the national and international policing capabilities set out by the Home Secretary
- bring together community safety and criminal justice partners, to make sure local priorities are joined up
- publishing an annual report
- securing the maintenance of an efficient and effective police force for the area
- responsibility for holding community safety budgets and commissioning services

# **Police and Crime Panels**

The Durham PCC and Constabulary area covers the local authorities of Durham County Council and Darlington Borough Council. The Police and Social Responsibility Act 2011 statutorily require the two constituent authorities within Durham Constabulary area to create a Police and Crime Panel.



The Durham Police and Crime Panel held its inaugural meeting in October 2012 and the Panel is hosted by Durham County Council. A web page containing information on the panel including the panel arrangements can be accessed here: https://www.durham.gov.uk/policeandcrimepanel

The Panel's membership consists of ten elected members for the constituent authorities and two co-opted independent members.

The Durham Police and Crime Commissioner is held to account by the Durham Police and Crime Panel. The role of the Durham Police and Crime Panel is to provide scrutiny of the Commissioner, but also has decision making powers and is required to provide support to the PCC in pursuit of objectives within the Police and Crime and Plan.

Within the Police Reform and Social Responsibility Act, the Panel's key responsibilities are:

- to review the draft Police and Crime Plan
- to publicly scrutinise the Police and Crime Commissioner's (PCC's) annual report
- to review and scrutinise decisions and actions by the PCC
- to review the PCC's proposed precept levels
- to review the PCC's conduct
- to review and confirm the PCC's proposed appointments of Chief Constable, Chief Executive, Chief Finance Officer, and Deputy Police and Crime Commissioner

The Act also includes procedures and processes for undertaking the above responsibilities and the panel are required to publish reports following reviewing the PCC's annual report, police, crime and victims' plan, precept and confirmation hearings. The panel also has a power of veto on the PCC's precept and proposed appointment of Chief Constable.

# **Panel Membership**

The Panel is politically balanced and consists of 12 members, seven elected members from Durham County Council, three elected members from Darlington Borough Council and two independent co-opted members. In addition, each elected member has a nominated substitute member. The Panel's membership for 2023/24 is below and includes nominated substitutes.

# **Complaints**

The Panel has responsibilities within the Elected Local Policing Bodies (Complaints and Misconduct) Regulations 2012 to record and consider non-criminal complaints made against the PCC. An update on complaints received is presented at each panel meeting.

During 2023/24, there were two complaints received for consideration by the Police and Crime Panel. The first complaint was heard by the Panel at its special meeting on 6 April 2023. The second complaint was heard by the Panel at its meeting held on 14 December 2023.

In accordance with Reg 28 (13) of the Elected Local Policing Bodies (Complaints and Misconduct) Regulations 2012, the Panel resolved not to publish the outcome of either of the complaints.

# **Engagement by the public and the PCC**

Durham County Council as host authority has a PCP webpage that provides an overview of the panel and the PCC's role and responsibilities. It also

includes the panel's arrangements, complaints procedure and links to agendas and minutes and the PCC's webpage.

The Panel's meetings during 2023/24 have been held at County Hall, Durham with the December meeting held in the Town Hall, Darlington. In addition, activity from Police and Crime Panel meetings has received coverage with local media.

## **Engagement with the Office of the PCC**

The Panel has a professional and positive relationship with the OPCC. Throughout 2023/24 engagement has included arrangements and preparations for the PCP's work programme, development sessions, consideration of the PCC's annual report and precept, undertaking confirmation hearings and the PPC's revised performance reporting arrangements.

At its meeting in June 2023, the panel considered the Joint Independent Audit Committee Annual report 2022-23 presented by the PCC and which provides detail of the assurance and risk management frameworks within which the PCC and Chief Constable operates.

At the Panel meeting in September 2023, members received an update report from the PCC on how she was holding Durham Constabulary to account for the delivery of recommendations by the Independent Inquiry into Child Sexual Abuse (IICSA). The PCC confirmed that she was confident that Durham Police were considering the work appropriately and continue to track progress.

The Panel considered the National Association of Police, Fire and Crime Panels' Annual Report 2023 in February 2024 and has worked with the PCC to bring follow up reports to the Panel in respect of police recruitment and vetting procedures and acceptable behaviours and standards within Durham Constabulary.

There has been regular engagement between the Panel secretariat, the overview and scrutiny officer and the OPCC. Engagement ensures a planned approach to the Panel's work programme with meetings considering the PCC's annual report 2022/23, the new style comprehensive performance management reports and HMICFRS Inspection reports. The Panel has also received reports following requests from members for update information on the new investigative hub and a former telecommunications mast located on the site of the former police headquarters.

The office of the PCC has also shared with the panel secretariat press releases for circulation to panel members upon release.

## **Responding to Government Consultations**

The Panel provided feedback to the Home Office on the questioning process for confirmation hearings in December 2023.

# **Panel Support**

The Panel receives financial support through grant funding from the Home Office. The grant enables the host to claim up to £64,340 for administration and members expenses.

Total panel expenditure for 2023/24 was £110,957.81 with £64,340 to be recovered from the central government grant and the variance met by the host authority. A breakdown of expenditure is listed in the table below.
