Re: Applications Submitted by Johnson Brothers to alter the Definitive Map Cassop cum Quarrington Parish
Cassop cum Quarrington Footpath No.29 – delete part of footpath

Further to your letter of 16 March 2012, I note that Messrs. Johnson Brothers have made an application for the deletion of part of footpath no.29 and to add another footpath onto the land owned by Redscape Limited. You kindly sent me your draft report on this issue and I can report that the recorded route of footpath no.29 is the correct route and is clearly used by the public.

The footpath is shown on the Definitive Map and also clearly exists on the ground, despite the attempts to block off the footpath on the land owner by Messrs. Johnson Brothers.

Prior to Redscape purchasing the land within their ownership, searches were made by the companies' solicitors to establish the line of the footpath, which was clearly shown on the Definitive Map, and they reported such accordingly. This has been the line of the footpath and remains so to the present day. People use the footpath intermittently and it is acknowledged by all that this is the correct route of the footpath.
