Request for Dispensation Under Section 85(1) of the Local Government Act 1972

## **Purpose of the Report**

To request Council to approve a dispensation for a Member currently unable to attend any Council meetings due to ill-health.

# **Executive summary**

Section 85 of the Local Government Act 1972 states that where a Member fails throughout a period of six consecutive months from the date of their last attendance to attend any meeting of the authority, then, subject to certain exceptions, he/she ceases to become a Member of the authority unless the failure was due to some reason approved before the expiry of that period. A request for dispensation has been received which is recommended for approval.

#### Recommendation

The Council is recommended to approve the request for dispensation under section 85(1) of the Local Government Act 1972.

### **Background**

- 4 Section 85(1) of the Local Government Act 1972 provides that:
  - "....If a member of a local authority fails throughout a period of six consecutive months from the date of his last attendance to attend any meeting of the authority, he shall, unless the failure was due to some reason approved by the authority before the expiry of that period, cease to be a member of the authority".
- Due to a period of ill-health Councillor Mamie Simmons has been unable to attend any meetings since 26 June 2024. The expiry of the six-month period in this case would be 26 December 2024.
- The authority for granting a dispensation of this nature rests with full council.
- 7 The Monitoring Officer is aware of the reasons for Councillor Simmons' absence and considers it appropriate for Council to grant the dispensation.

#### Conclusion

8 Unless the Council agrees the recommendation, Councillor Simmons will cease to be a member of the Council on 26 December 2024.

# **Appendix 1: Implications**

### **Legal Implications**

A Councillor who fails to attend any meeting of the authority for six months ceases to be a Member unless a dispensation has been granted by the Authority concerned. The dispensation must be agreed before the expiry of the six-month period.

#### **Finance**

Failure to agree the dispensation for Councillor Simmons would result in a vacancy on the Council. If Councillor Simmons did not attend a qualifying meeting by 26 December 2024 this would lead to a by-election being called. The Council would incur costs in respect of administering the by-election.
